

Mark L. Goldstein
Biography

Mark L. Goldstein is a director of physical infrastructure issues at the United States Government Accountability Office (GAO), the investigative and audit agency of the U.S. Congress. Mr. Goldstein is responsible for GAO's work in the areas of government property and telecommunications. Mr. Goldstein has held other public sector positions, serving as deputy executive director and chief of staff to the District of Columbia Financial Control Board, legislative advisor to the Commissioner of Internal Revenue, and a senior staff member of the United States Senate Committee on Homeland Security and Governmental Affairs. Prior to government service, Mr. Goldstein was an investigative journalist and author. Mr. Goldstein's book, *America's Hollow Government: How Washington Has Failed the People* (1993:Dow Jones), received awards from the American Library Association. Mr. Goldstein has also earned honors from the Associated Press, the Society of American Business Press Editors, the American Society for Public Administration, and GAO.

Mr. Goldstein holds a BS in Journalism from Syracuse University, an MPA from George Washington University, an MA from the University of Maryland, and is currently a Ph.D. candidate at the University of Maryland. Mr. Goldstein is an elected fellow of the National Academy of Public Administration and has been awarded professional and research fellowships at the John F. Kennedy School of Government at Harvard University and at Wolfson College at Cambridge University, England. He is an adjunct lecturer in American History at the University of Maryland at College Park.

Mr. Goldstein testifies frequently before the United States Congress and has appeared on national network news programs such as CNN, C-SPAN, National Public Radio, and ABC Evening News.
