Mr. <u>Bilirakis.</u> The subcommittee will come to order, the chairman recognizes himself for an opening statement.

Good afternoon. The Anti-Spoofing Act is an important piece of legislation for all of our constituents. Countless people across our Nation have been victims of the unethical and illegal tactics of falsified caller ID information.

Earlier this year, one of my constituents from Tampa told me his family's story. His telephone information was stolen and used to make thousands of automated calls around the country. He then stated, and I quote: "We started receiving phone calls from hundreds of people a day. These callbacks ranged from the irate to the confused but have made the use of our phone impossible," end quote. This constituent was forced to replace their phone hardware, lost the regular use of their home phone, and had to change his home phone number of 15 years to get the peace he deserves in his own home. This should not happen. This is just one of thousands of stories around the country.

I am glad that we will move forward with the Anti-Spoofing Act today to further prevent the use of false caller ID information and protect the privacy of our constituents.

I am also pleased to see a markup on the Improving Rural Call Quality and Reliability Act to ensure our most rural communities and businesses have access to high-quality landline connections. This continues our efforts to help promote quality of life and opportunity for all Americans.
