The Subcommittee on Communications and Technology will meet in **open markup session** on Thursday, November 14, 2019, at 11:30 a.m. in the John D. Dingell Room, 2123 of the Rayburn House Office Building, and subsequent days as necessary, to consider the following legislation:

1. **H.R. 4229**, the “Broadband Deployment Accuracy and Technological Availability Act (Broadband DATA Act)”;
2. **H.R. 4227**, the “Mapping Accuracy Promotes Services (MAPS) Act”;
3. **H.R. 5000**, the “Studying How to Harness Airwave Resources Efficiently (SHARE) Act of 2019”;
4. **H.R. 4998**, the “Secure and Trusted Communications Networks Act”;
5. **H.R. 4461**, the “Network Security Information Sharing Act of 2019”;
6. **H.R. 2881**, the “Secure 5G and Beyond Act of 2019”;
7. **H.R. 4500**, the “Promoting United States Wireless Leadership Act of 2019”;
8. **H. Res. 575**, expressing the sense of the House of Representatives that all stakeholders in the deployment of 5G communications infrastructure should carefully consider and adhere to the recommendation of “The Prague Proposals”; and
9. **H.R. 5035**, the “Television Viewer Protection Act”.

The prompt attendance of all Members is requested at this markup. The bipartisan staff briefing for the markup will be held on Wednesday, November 13, 2019, at 3:30 p.m. in room 2123 of the Rayburn House Office Building. Following this briefing, the Democratic staff will meet in the same room. The Republican staff will meet in room 2322 of the Rayburn House Office Building.

In keeping with past committee practice, each Member must submit their amendments at least two hours before any such amendment can be offered or considered at markup.
