 - 1 Be it enacted by the Senate and House of Representa-
 - 2 tives of the United States of America in Congress assembled,
 - 3 SECTION 1. REPORT ON DIGITAL DIVIDE.
 - 4 (a) REPORT REQUIRED.—Not later than 1 year after
 - 5 the date of the enactment of this Act, and annually there-
 - 6 after for the subsequent 10-year period, the Assistant Sec-

1	retary, in consultation with the Federal Communications
2	Commission, shall submit to the Committee on Energy
3	and Commerce of the House of Representatives and the
4	Committee on Commerce, Science, and Transportation of
5	the Senate, and make publicly available on the website of
6	the NTIA, a report on the state of the digital divide, which
7	shall include the following:
8	(1) Information on and an analysis of—
9	 (Λ) barriers to, and trends regarding,
10	broadband access, adoption, and affordability;
11	(B) the connection between—
12	(i) broadband access, adoption, and
13	affordability; and
14	(ii) various socioeconomic indicators;
15	and
16	(C) the impact of Federal programs on
17	broadband access, adoption, and affordability.
18	(2) An assessment of the sufficiency of existing
19	data collection and data sets with respect to the
20	analysis described in paragraph (1) and, if nec-
21	essary, recommendations for NTIA actions to im-
22	prove data quality.
23	(3) Recommendations for legislative action to
24	facilitate closure of the digital divide.

1	(b) Assemblay Process.—In assembling each report
2	required by subsection (a), the Assistant Secretary shall—
3	(1) utilize all available and relevant data, in-
4	cluding data associated with the Indicators of
5	Broadband Need mapping application of the NTIA
6	and published research and data from individuals
7	and entities other than the NTIA;
8	(2) solicit public comment;
9	(3) hold public meetings with relevant stake-
10	holders; and
11	(4) consult with experts on and representatives
12	of communities that are unserved or underserved
13	with respect to broadband.
14	SEC. 2. INDICATORS OF BROADBAND NEED MAPPING AP-
15	PLICATION.
16	(a) UPDATE REQUIRED.—Not later than 180 days
17	after the date of the enactment of this Act, and every 180
18	days thereafter, the Assistant Secretary shall update the
19	Indicators of Broadband Need mapping application of the
20	NTLA to ensure that such application incorporates, and
21	includes display layers with respect to, the following:
22	(1) Data from the Broadband Data Collection
23	system of the Federal Communications Commission,
24	including data on availability and subscription rates
25	for broadband tiers with a download speed of more

1	than 25 megabits per second and an upload speed
2	of more than 3 megabits per second.
3	(2) Third-party data on the results of mobile
4	network speed and signal strength tests.
5	(3) The identification of—
6	(A) areas of persistent poverty (as such
7	term is defined in section 6702(a) of title 49,
8	United States Code);
9	(B) historically disadvantaged communities
10	(as such term is used in section 6702 of title
11	49, United States Code);
12	(C) areas impacted by previous redlining
13	practices (as determined using maps produced
14	by the Home Owners' Loan Corporation); and
15	(D) congressional districts.
16	(4) Data on eligibility and enrollment with re-
17	spect to the Affordable Connectivity Program estab-
18	lished under section 904(b) of division N of the Con-
19	solidated Appropriations Act, 2021 (47 U.S.C.
20	1752).
21	(b) Rule of Construction.—Nothing in this sec-
22	tion may be construed to limit the authority of the Assist-
23	ant Secretary to incorporate, as part of the Indicators of
24	Broadband Need mapping application of the NTIA, ele-

	1	ments in addition to the elements identified in subsection
	2	(a).
