A BILL

To improve motor vehicle safety by encouraging the sharing of certain information.

1 Be it enacted by the Senate and House of Representa-

2 tives of the United States of America in Congress assembled,

3 SECTION 1. SHORT TITLE.

4 This Act may be cited as the "Motor Vehicle Safety

5 Whistleblower Act".

SEC. 2. MOTOR VEHICLE SAFETY WHISTLEBLOWER INCEN TIVES AND PROTECTIONS. (a) IN GENERAL.—Subchapter IV of chapter 301 of

4 title 49, United States Code, is amended by adding at the5 end the following:

6 "§ 30172. Whistleblower incentives and protections

7 "(a) DEFINITIONS.—In this section:

8 "(1) COVERED ACTION.—The term 'covered ac-9 tion' means any administrative or judicial action, in-10 cluding any related administrative or judicial action, 11 brought by the Secretary or the Attorney General 12 under this chapter that in the aggregate results in 13 monetary sanctions exceeding \$1,000,000.

14 "(2) MONETARY SANCTIONS.—The term 'mone15 tary sanctions' means monies, including penalties
16 and interest, ordered or agreed to be paid.

17 "(3) ORIGINAL INFORMATION.—The term
18 'original information' means information that—

19 "(A) is derived from the independent20 knowledge or analysis of an individual;

21 "(B) is not known to the Secretary from
22 any other source, unless the individual is the
23 original source of the information; and

24 "(C) is not exclusively derived from an al25 legation made in a judicial or an administrative
26 action, in a governmental report, a hearing, an

audit, or an investigation, or from the news
 media, unless the individual is a source of the
 information.

4 "(4) PART SUPPLIER.—The term 'part supplier'
5 means a manufacturer of motor vehicle equipment.
6 "(5) SUCCESSFUL RESOLUTION.—The term
7 'successful resolution' includes any settlement or adjudication of a covered action.

9 "(6) WHISTLEBLOWER.—The term 'whistle-10 blower' means any employee or contractor of a 11 motor vehicle manufacturer, part supplier, or dealer-12 ship who voluntarily provides to the Secretary origi-13 nal information relating to any motor vehicle defect, 14 noncompliance, or any violation or alleged violation 15 of any notification or reporting requirement of this 16 chapter which is likely to cause unreasonable risk of 17 death or serious physical injury.

18 "(b) Awards.—

"(1) IN GENERAL.—If the original information
that a whistleblower provided to the Secretary led to
the successful resolution of a covered action, the
Secretary, subject to subsection (c), may pay an
award or awards to 1 or more whistleblowers in an
aggregate amount of not more than 30 percent, in
total, of collected monetary sanctions.

1	"(2) PAYMENT OF AWARDS.—Any amount pay-
2	able under paragraph (1) shall be paid from the
3	monetary sanctions collected, and any monetary
4	sanctions so collected shall be available for such pay-
5	ment.
6	"(c) Determination of Awards; Denial of
7	Awards.—
8	"(1) Determination of awards.—
9	"(A) DISCRETION.—The determination of
10	whether, to whom, or in what amount to make
11	an award shall be in the discretion of the Sec-
12	retary.
13	"(B) CRITERIA.—In determining an award
14	made under subsection (b), the Secretary shall
15	take into consideration—
16	"(i) if appropriate, whether a whistle-
17	blower reported or attempted to report the
18	information internally to an applicable
19	motor vehicle manufacturer, part supplier,
20	or dealership;
21	"(ii) the significance of the original
22	information provided by the whistleblower
23	to the successful resolution of the covered
24	action;

1	"(iii) the degree of assistance provided
2	by the whistleblower and any legal rep-
3	resentative of the whistleblower in the cov-
4	ered action; and
5	"(iv) such additional factors as the
6	Secretary considers relevant.
7	"(2) DENIAL OF AWARDS.—No award under
8	subsection (b) shall be made—
9	"(A) to any whistleblower who is convicted
10	of a criminal violation related to the covered ac-
11	tion for which the whistleblower otherwise could
12	receive an award under this section;
13	"(B) to any whistleblower who, acting
14	without direction from an applicable motor ve-
15	hicle manufacturer, part supplier, or dealership,
16	or agent thereof, deliberately causes or substan-
17	tially contributes to the alleged violation of a
18	requirement of this chapter;
19	"(C) to any whistleblower who submits in-
20	formation to the Secretary that is based on the
21	facts underlying the covered action submitted
22	previously by another whistleblower;
23	"(D) to any whistleblower who fails to pro-
24	vide the original information to the Secretary in

1	such form as the Secretary may require by reg-
2	ulation; or
3	"(E) to any whistleblower who fails to re-
4	port or attempt to report the information inter-
5	nally to an applicable motor vehicle manufac-
6	turer, parts supplier, or dealership, unless—
7	"(i) the whistleblower reasonably be-
8	lieved that such an internal report would
9	have resulted in retaliation, notwith-
10	standing section 30171(a); or
11	"(ii) the whistleblower reasonably be-
12	lieved that the information—
13	"(I) was already internally re-
14	ported;
15	"(II) was already subject to or
16	part of an internal inquiry or inves-
17	tigation; or
18	"(III) was otherwise already
19	known to the motor vehicle manufac-
20	turer, part supplier, or dealership.
21	"(d) Representation.—A whistleblower may be
22	represented by counsel.
23	"(e) NO CONTRACT NECESSARY.—No contract with
24	the Secretary is necessary for any whistleblower to receive
25	an award under subsection (b).

"(f) PROTECTION OF WHISTLEBLOWERS; CONFIDEN TIALITY.—

3	"(1) IN GENERAL.—Notwithstanding section
4	30167, and except as provided in paragraphs (4)
5	and (5) of this subsection, the Secretary, and any
6	officer or employee of the Department of Transpor-
7	tation, shall not disclose any information, including
8	information provided by a whistleblower to the Sec-
9	retary, which could reasonably be expected to reveal
10	the identity of a whistleblower, except in accordance
11	with the provisions of section 552a of title 5, un-
12	less—
13	"(A) required to be disclosed to a defend-
14	ant or respondent in connection with a public
15	proceeding instituted by the Secretary or any
16	entity described in paragraph (5);
17	"(B) the whistleblower provides prior writ-
18	ten consent for the information to be disclosed;
19	or
20	"(C) the Secretary, or other officer or em-
21	ployee of the Department of Transportation, re-
22	ceives the information through another source,
23	such as during an inspection or investigation
24	under section 30166, and has authority under

other law to release the information.

1	"(2) REDACTION.—The Secretary, and any offi-
2	cer or employee of the Department of Transpor-
3	tation, shall take reasonable measures to not reveal
4	the identity of the whistleblower when disclosing any
5	information under paragraph (1).
6	"(3) Section $552(b)(3)(B)$.—For purposes of
7	section 552 of title 5, paragraph (1) of this sub-
8	section shall be considered a statute described in
9	subsection $(b)(3)(B)$ of that section.
10	"(4) Effect.—Nothing in this subsection is
11	intended to limit the ability of the Attorney General
12	to present such evidence to a grand jury or to share
13	such evidence with potential witnesses or defendants
14	in the course of an ongoing criminal investigation.
15	"(5) AVAILABILITY TO GOVERNMENT AGEN-
16	CIES.—
17	"(A) IN GENERAL.—Without the loss of its
18	status as confidential in the hands of the Sec-
19	retary, all information referred to in paragraph
20	(1) may, in the discretion of the Secretary,
21	when determined by the Secretary to be nec-
22	essary or appropriate to accomplish the pur-
23	poses of this chapter and in accordance with
24	subparagraph (B), be made available to the fol-
25	lowing:

1 "(i) The Department of Justice. 2 "(ii) An appropriate department or agency of the Federal Government, acting 3 4 within the scope of its jurisdiction. "(B) MAINTENANCE OF INFORMATION.-5 6 Each entity described in subparagraph (A) shall 7 maintain information described in that subpara-8 graph as confidential, in accordance with the 9 requirements in paragraph (1). 10 "(g) PROVISION OF FALSE INFORMATION.—A whis-11 tleblower who knowingly and willfully makes any false, fic-12 titious, or fraudulent statement or representation, or who makes or uses any false writing or document knowing the 13 14 same to contain any false, fictitious, or fraudulent state-15 ment or entry, shall not be entitled to an award under

16 this section and shall be subject to prosecution under sec-17 tion 1001 of title 18.

18 "(h) Appeals.—

"(1) IN GENERAL.—Any determination made
under this section, including whether, to whom, or in
what amount to make an award, shall be in the discretion of the Secretary.

23 "(2) APPEALS.—Any determination made by
24 the Secretary under this section may be appealed by
25 a whistleblower to the appropriate court of appeals

of the United States not later than 30 days after the
 determination is issued by the Secretary.

3 "(3) REVIEW.—The court shall review the de4 termination made by the Secretary in accordance
5 with section 706 of title 5.

6 "(i) REGULATIONS.—Not later than 18 months after
7 the date of enactment of the Motor Vehicle Safety Whistle8 blower Act, the Secretary shall promulgate regulations on
9 the requirements of this section, consistent with this sec10 tion.".

11 (b) RULE OF CONSTRUCTION.—

12 (1) ORIGINAL INFORMATION.—Information submitted to the Secretary of Transportation by a whis-13 14 tleblower in accordance with the requirements of sec-15 tion 30172 of title 49, United States Code, shall not 16 lose its status as original information solely because 17 the whistleblower submitted the information prior to 18 the effective date of the regulations if that informa-19 tion was submitted after the date of enactment of 20 this Act.

(2) AWARDS.—A whistleblower may receive an
award under section 30172 of title 49, United States
Code, regardless of whether the violation underlying
the covered action occurred prior to the date of enactment of this Act, and may receive an award prior

- 1 to the Secretary of Transportation promulgating the
- 2 regulations under section 30172(i) of that title.

3 (c) CONFORMING AMENDMENTS.—The table of con4 tents of subchapter IV of chapter 301 of title 49, United
5 States Code, is amended by adding at the end the fol6 lowing:

"30172. Whistleblower incentives and protections.".
