Neal Orringer is Vice President for Alliances and Partnerships at 3D Systems. He leads research and qualification partnerships with the federal government, as well as major aerospace and defense suppliers. His responsibilities include overseeing several Air Force and DARPA-sponsored research projects associated with direct metal printing and Cooperative R&D Agreements with the U.S. Army and Navy.

Mr. Orringer is also a visiting researcher at the U.S. Army Research Laboratory, focused on accelerating to market innovations in new production materials, processes, and applications for the American warfighter.

Previously, he served in key positions in the Obama administration and U.S. Senate, focused on manufacturing business and technology. Most recently he supported the White House Office of Manufacturing Policy, as part of the Secretary of Commerce's core policy team. He also served at the Department of Defense as Director of Manufacturing, overseeing Manufacturing Technology, Defense Production Act, industrial base sustainment programs.



In 2012, he was awarded the *Office of the Secretary of Defense Exceptional Civilian Service Medal* for his pioneering management and outstanding record of achievement. Mr. Orringer led President Obama's effort to pilot the first of several institutes among the National Network for Manufacturing Innovation, teaming large corporations, small/medium sized companies, industry start-ups, and academia to field new technology into the market. In 2013, Mr. Orringer and his team were awarded the *Secretary of Defense Award for Excellence*.

Mr. Orringer served for 11 years on Capitol Hill, including on the U.S. Senate Committee on Banking, Housing, & Urban Affairs staff, supporting Chairman Christopher J. Dodd in the Senate's proposal and oversight of federal aid to General Motors and Chrysler.

Today, Mr. Orringer serves on several civic boards, including the Virginia Tech Science and Engineering Regional Growth Enterprise (VT-SERGE) Board, Penn State Center Innovative Materials Processing Through Direct Digital Deposition, and the Montgomery County Public School Budget Steering Committee.

He holds a B.A. in politics and economics from Brandeis University and a M.A. from Georgetown University in National Security Studies. He lives in Bethesda, Maryland together with his wife, Dr. Erika Schwartz and two children, Gabrielle and Frederick.
