

## Biography of Peter Schoenke

Peter Schoenke is the Co-Founder and President of RotoWire.com, a leading content and technology provider to fantasy sports consumers and media companies including ESPN, Yahoo! Sports, Fox Sports, FanDuel, DraftKings and Sirius XM Radio.

RotoWire has been the leading innovator in the fantasy sports industry since the hobby moved online. Founded in 1997, the company developed the concept of “player notes” and the industry continues to follow its format of using a “news” and “analysis” section for each update.

Mr. Schoenke has been Chairman of the Fantasy Sports Trade Association since 2010 and a board member since 2002. Mr. Schoenke has led the FSTA's efforts to fully legalize fantasy sports in all 50 states which has resulted in the passage of laws in Maryland in 2012, Kansas in 2015 and Virginia, Indiana and Tennessee in 2016. He has testified in seven state legislatures in support of legislation.

Mr. Schoenke was elected to the FSTA hall of fame in 2011 for achievement in developing the fantasy sports industry and to the Fantasy Sports Writers Association hall of fame in 2012 for achievement in fantasy sports writing.

Mr. Schoenke is a former editor for Investment Dealers' Digest and a reporter for Dow Jones and contributor to the Wall Street Journal. He holds a master's degree in journalism and a B.A. in economics and political science from Northwestern University.
