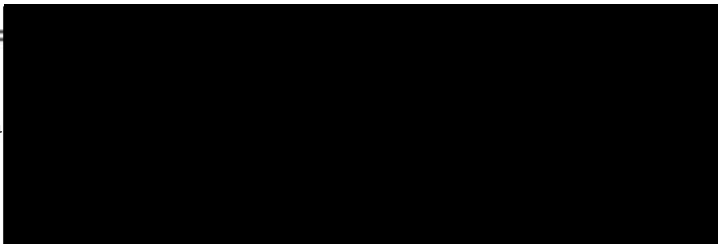

Driven information technology executive with 30 years of proven track record leading and transforming IT organizations achieving sustainable business results. Experience working across multiple industries including Fortune 500 and privately held companies. Fluent with a broad range of business processes and enabling IT solutions delivering business outcomes, service level goals, while reducing IT related business risks and operating costs. Accountable for financial management of nearly \$60M of annual IT spend. Coordinated the development of IT strategy, and go forward SAP strategy aligned with the business plans and objectives.
