Strike all after the enacting clause and insert the following:

1	SECTION 1. SHORT TITLE.
2	This Act may be cited as the "Save America's For-
3	gotten Equines Act of 2022" or the "SAFE Act of 2022".
4	SEC. 2. PROHIBITION ON SHIPPING, TRANSPORTING, MOV-
5	ING, DELIVERING, RECEIVING, POSSESSING,
6	PURCHASING, SELLING, OR DONATION OF
7	HORSES AND OTHER EQUINES FOR SLAUGH-
8	TER FOR HUMAN CONSUMPTION.
9	(a) Definitions.—Section 2 of the Horse Protection
10	Act (15 U.S.C. 1821) is amended—
11	(1) by redesignating paragraphs (1), (2), (3),
12	and (4) as paragraphs (2), (3), (5), and (6), respec-
13	tively;
14	(2) by inserting before paragraph (2), as so re-
15	designated, the following new paragraph:
16	"(1) The term 'human consumption' means ingestion
17	by people as a source of food."; and

1	(3) by inserting after paragraph (3), as so re-
2	designated, the following new paragraph:
3	"(4) The term 'slaughter' means the killing of one
4	or more horses or other equines with the intent to sell
5	or trade the flesh of such horses or equines for human
6	consumption.".
7	(b) FINDINGS.—Section 3 of the Horse Protection
8	Act (15 U.S.C. 1822) is amended—
9	(1) by redesignating paragraphs (1), (2), (3),
10	(4), and (5) as paragraphs (5), (6), (7), (9), and
11	(10), respectively;
12	(2) by inserting before paragraph (5), as so re-
13	designated, the following new paragraphs:
14	"(1) horses and other equines play a vital role
15	in the collective experience of the United States and
16	deserve protection and compassion;
17	"(2) horses and other equines are domestic ani-
18	mals that are used primarily for recreation, pleasure,
19	work, and sport;
20	"(3) unlike cows, pigs, and many other animals,
21	horses and other equines are not raised for the pur-
22	pose of being slaughtered for human consumption;
23	"(4) individuals selling horses or other equines
24	at auctions are seldom aware that the animals may

1	be bought for the purpose of being slaughtered for
2	human consumption;"; and
3	(3) by inserting after paragraph (7), as so re-
4	designated, the following new paragraph:
5	"(8) the shipping, transporting, moving, deliv-
6	ering, receiving, possessing, purchasing, selling, or
7	donation in intrastate commerce of horses and other
8	equines to be slaughtered for human consumption,
9	adversely affects and burdens interstate and foreign
10	commerce;".
11	(c) Prohibition.—Section 5 of the Horse Protection
12	Act (15 U.S.C. 1824) is amended—
13	(1) by redesignating paragraphs (8) through
14	(11) as paragraphs (9) through (12), respectively;
15	and
16	(2) by inserting after paragraph (7) the fol-
17	lowing new paragraph:
18	"(8) The shipping, transporting, moving, deliv-
19	ering, receiving, possessing, purchasing, selling, or
20	donation by a person of any horse or other equine
21	that the person has reason to believe will be slaugh-
