Viasystems manufactures in both North America and China. Within its PCB business, Viasystems operates 12 dedicated PCB facilities, leveraging both leading-edge technology and high volume capacity locations. The Electro-Mechanical Solutions division has three dedicated manufacturing locations in Mexico and China.

Dr. Grazman started his career at the National Institute for Standards and Technology (NIST), where he worked in the National Measurement Laboratory while completing his Ph.D. in Nuclear Analytical Chemistry from Texas A&M University. He went into the Consumer Products industry as a research scientist, holding a series of positions of increasing responsibility on the R&D/product development ladder. He moved into Industrial Products and Building Materials before being asked to bring the tools of R&D to Quality and Continuous Improvement at GAF Materials Corporation.

In the Continuous Improvement area, he led the early Six Sigma efforts at such companies as GE Capital Mortgage Services and Amazon.com, and served as a consultant supporting companies including Coca Cola, Yum Brands and Motorola.

Brent and his wife Debbie reside in Chesterfield, Missouri and have two daughters—one in high school and one at Miami University of Ohio—and also share their home with both a rescued cattle dog and cat.
