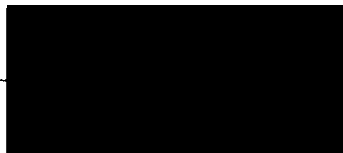

Responsible for all aspects of the organization's national issue campaigns as well as other responsibilities as part of Executive Management Team. Clean Water Action is a 40-year old 1-million member organization which works in 15 states and on the federal level on health and environmental issues. The organization's programs cover water issues, global warming and clean energy issues and chemical policy.

Program Development: Responsible for development, planning and implementation of policies and programmatic activities across a wide range of issue areas.

Policy Expertise: Recognized expert on Safe Drinking Water Act implementation and drinking water issues. Has served on numerous Federal Advisory Committees and other formal bodies engaged in advising the U.S. Environmental Protection Agency (EPA) on drinking water issues, negotiating SDWA rules and other activities. (See below.) Works in collaboration with other NGO's, drinking water trade associations and drinking water sector research organizations.

Involved in planning and implementation of other aspects of fundraising including membership development, direct mail, major donor cultivation and field and phone canvass programs.

Accomplished meeting facilitator and public speaker for a variety of audiences.
