## Biography of Lisa D. Johnson CEO & General Manager



On July 30, 2013, Lisa D. Johnson began serving as Seminole's fifth Chief Executive Officer and General Manager. As Seminole's CEO, she is responsible for overall Cooperative operations. She reports directly to Seminole's Board of Trustees.

Prior to joining Seminole, Johnson served as senior vice president and chief operating officer of Old Dominion Electric Cooperative (ODEC) in Glen Allen, Va. Johnson joined ODEC in 2006 following an 11-year tenure with Mirant Corporation and Southern Company.

Johnson holds a Bachelor of Science degree in mechanical

engineering and materials science from Duke University. She serves as a director on the Florida Reliability Coordinating Council, secretary/treasurer of the Florida Electric Power Coordinating Group, a trustee on the Board of Averett University, a director on the Board of the Florida Electric Cooperatives Association and also serving as a member of the Executive Committee, a director on the Board of the Electric Power Research Institute, and was named one of Virginia's most "Influential Women" in 2012.

Seminole Electric Cooperative is one of the largest generation and transmission cooperatives in the country. Its mission is to provide reliable, competitively priced, wholesale electric power to its nine, not-for-profit, Member-owned distribution electric cooperatives. Approximately 1.4 million people and businesses in parts of 42 Florida counties rely on Seminole Member cooperatives for electricity. Seminole's primary resources include the Seminole Generating Station (SGS) in northeast Florida and the Richard J. Midulla Generating Station (MGS) in south central Florida.
