- Founder and Executive Director of EIP, a nonprofit public interest group dedicated to improving enforcement of environmental laws
- Established organization after resigning from US Environmental Protection Agency in March of 2002
- EIP combines advocacy and original research to help focus public attention on chronic violations by power plants, refineries, factory farms, and other large sources of pollution; also helps communities review permits and file enforcement actions when necessary

U.S. Environmental Protection Agency's Office of Civil Enforcement

- Responsible for securing compliance with the Clean Air Act, the Clean Water Act, and federal right-to-know and hazardous waste laws
- Targeted “grandfathered” power plants and refineries for cleanup through industry-wide enforcement initiatives that led to reduction of more than one million tons of sulfur dioxide
- Received Presidential Rank Award from the USEPA, and John Marshall Award from the U.S. Department of Justice.
