

Regulatory Advocacy

- Chemical Security. Helped position chemical industry as leading sector in development & rollout of DHS regulatory and voluntary security programs, without compromising ACC's goals. Responsible for Coast Guard recognition of ACC's Responsible Care Security Code as an Alternative Security Program under Coast Guard Maritime Transportation Security Act regulations. Drove DHS exemption of critical infrastructure sector coordinating councils from Federal Advisory Committee Act. Guided ACC's advocacy with DHS, Coast Guard, DOJ.
- <u>Information quality</u>. Provided most influential private sector input to OMB on Information Quality Act Guidelines and Peer Review Bulletin, EPA IQA guidelines. Stopped EPA "Third-Party Assessment Factors."
- Enforcement. In charge of ACC's enforcement/compliance advocacy 1993-2007. Stopped EPA Region VII "Continuous Release Reporting" enforcement initiative; led coalition litigation against resulting EPA guidance on federally-permitted releases; negotiated current, favorable guidance. Led regulated community efforts to stop hugely costly EPA proposal on electronic recordkeeping & reporting (CROMERRR) and avert

EPA guidance on "illegal competitive advantage." Played leading role in getting U.S. Sentencing Commission to reverse 2004 amendments to federal organizational sentencing guidelines. Helped negotiate EPA audit/disclosure policy. Co-led numerous EPA/ACC joint projects to understand the causes of noncompliance and to generate compliance tools; delayed and softened traditional enforcement initiative against chemical sector. Played significant role in design and initial launch of EPA Performance Track program; founded Performance Track Participants Association.

- RCRA. From 1993-98, responsible for roughly 60% of CMA's RCRA advocacy, as counsel to work groups on hazardous waste combustion, waste identification, RCRA legislation, nonhazardous waste, and interstate waste restrictions. Provided leadership to successful advocacy for "comparable fuels" exemption from RCRA regulation.
- <u>Air monitoring</u>. In mid 1990s, led multi-industry effort to stop EPA's "enhanced monitoring" rule. Substantially ameliorated "compliance assurance monitoring" rule.

Legislative Advocacy

- Chemical facility security. Since 2001, centrally involved in consideration of federal chemical facility legislation, one of ACC's two highest-tier legislative issues. Played key role in enactment of such legislation in FY07 DHS approps law (Pub. L. No. 109-295). Drafted and negotiated legislative language and committee reports with Senate and House staff and Administration; successfully worked with GAO, CRS; drafted ACC testimony. Also helped draft and enact Critical Infrastructure Information Act (part of Homeland Security Act; Pub. L. No. 107-296, 6 U.S.C. §§ 131-34).
- <u>Attorney-client privilege</u>. Help lead coalition ranging from U.S Chamber to ACLU to change DOJ policy on waiver of attorney-client privilege. Catalyzed successful House and Senate hearings in 2006, caused DOJ to rescind its "Thompson Memo."
- Worst-case scenarios on the Internet. Helped draft and enact Chemical Safety
 Information, Site Security and Fuels Regulatory Relief Act (Pub. L. No. 106-40, 42
 U.S.C. § 7412(r)(7)(H)) and committee report. Through implementation of same, kept
 EPA from posting worst-case chemical release scenarios on the internet.
- <u>Formerly hazardous wastes</u>. Helped draft and enact Land Disposal Program Flexibility Act (Pub. L. No. 104-119, codified in scattered sections of 42 U.S.C. chapter 82). Worked closely with CEQ, EPA and industry coalition.
- Appropriations. Drafted, negotiated earmarks and report language adopted in multiple Congresses regarding topics such as EPA's IRIS database, EPA compliance assistance programs.
- Environmental audit privilege & disclosure. Helped lead coalition efforts in mid-1990s.
