

## **Ethan Zindler, Head of Americas, BloombergNEF**

Ethan Zindler is Head of Americas at BloombergNEF (BNEF), the world's leading provider of data, research and analysis on clean energy, advanced transportation, commodities, emerging technologies and other aspects of the transition to a lower-carbon economy. BNEF is a unit of global financial information provider Bloomberg LP.

Zindler manages BNEF's analyst and commercial teams in New York, Washington, San Francisco, and Sao Paulo. He also oversees a global team of analysts dedicated specifically to tracking policy developments for BNEF clients and directs [Climatescope](#), a major online public resource detailing clean energy investment conditions in all emerging market countries.

Over the course of 16 years with BNEF, Zindler has authored or edited thousands of analyst reports, white papers, and other documents on the economics of clean energy and the transition to a lower-carbon economy. Topics have included the economic viability of clean technologies, global investment trends, financing solutions and international trade disputes, among many others.

Zindler serves as BNEF's primary spokesperson for BNEF in Washington and has been quoted extensively in the media including in *The Wall Street Journal*, *New York Times* and *Washington Post*. He has testified numerous times before the U.S. Senate Energy & Natural Resources Committee, the Senate Finance Committee, the Canadian Parliament and two state legislatures. He is currently a Senior Associate (non-resident), at the Center for Strategic and International Studies Energy Security and Climate Change Program.

Before taking his current position, Zindler served as BNEF's Head of North American Research where he managed analysts in the U.S. and Brazil. He joined the firm originally known as New Energy Finance in 2005 as its first U.S.-based employee. New Energy Finance was sold to Bloomberg LP in December 2009.

Prior to NEF, Zindler spent two years reporting on the controversy surrounding the proposed Cape Wind offshore wind farm as the sole business reporter at *The Cape Cod Times*. Zindler's other prior experience includes stints in the White House Office of National Service, at MTV where he edited a web site devoted to political topics for young people, and as a freelance journalist covering two World Cup soccer tournaments.

Zindler holds an MBA from Columbia Business School and a BA from Georgetown University. He lives in Alexandria, VA with his wife and two daughters.
