

PATRICK B. FORD



PROFILE

Pat Ford has over 35 years of experience in economic and community development, from rural planning and zoning, to urban renewal, to the site-specific repurposing and redevelopment of brownfields. He has worked as a development executive in New York, West Virginia, Ohio, Kentucky, Pennsylvania, Virginia, Maryland, Texas, and Florida.

After earning both his undergraduate and master's degrees in city planning from the University of Virginia, Mr. Ford's work has taken him from college towns to mill towns to major cities as he served both the private and public sectors from New York to South Florida. Recently, Mr. Ford's efforts were recognized by West Virginia's West Liberty University, where he was invited to deliver the commencement address and awarded an Honorary Doctorate.

Mr. Ford's work as a director and vice president in the private sector, a city official in the public sector, and executive director in non-profit brownfields redevelopment have given him a triad of skills that enable him to identify and pursue projects backed by real funding, productive partnerships and with full knowledge of local, state, and federal regulatory requirements. He has a proven track record of moving projects from conception to ribbon cuttings.

Immediately prior to joining the Frontier Group of Companies, Mr. Ford served the Executive Director of the Marion County (KY) Industrial Foundation, a non-profit economic development organization with a strong financial footing. As the ED of that organization, Mr. Ford restructured interest-bearing accounts, expanded workforce initiatives, established an abandoned and dilapidated (BAD) building removal program, and oversaw the remediation and removal of an eyesore that had stood deteriorating in the gateway of the county for more 20 years.

Razing and repurposing brownfields properties became Mr. Ford's area of expertise during his decade with the Business Development Corp. of the Northern Panhandle (WV), where he first worked with Frontier Group of Companies to break the first fresh ground for manufacturing in Weirton, WV, in over 20 years. During his time in West Virginia's Northern Panhandle, Mr. Ford oversaw the BDC's ownership and repurposing of a total of seven former manufacturing sites, each re-energizing a different city or town in the two-county panhandle.

Mr. Ford's breadth of professional accomplishments includes closing the "Deal of the Week" in the Wall Street Journal, recognition by the US Small Business Administration as "Small Business Champion of the Year," recognition by the United States Environmental Protection Agency for Land Stewardship and Collaboration, a profile Brownfields Renewal Magazine, and being recognized as industry expert by the United States House of Representatives, West Virginia Brownfields Assistance Center, West Virginia Department of Environmental Protection, the Maryland Chapter of the American Planning Association, and the Virginia Citizens' Planning Association.

The foundation provides Marion County with development programs that are designed to grow the economy by increasing the productivity of local industry and commercial sectors of automotive, distilling, agriculture, healthcare, value-added metals, and plastics, and aid small business by providing a variety of services and incentives designed to retain and expand existing industries and to attract new industries and businesses.
- Established the MCIF COVID-19 RESPONSE HUB to provide a forum for our local industries and leaders to share best practices, policies, and implementation strategies with regards to re-openings, transitioning out of warm stand-by, and maintaining operations during this pandemic.
- Established PROJECT REBOUND which is a collaboration between the MCIF, Chamber of Commerce, Lebanon City Council, and Marion County Fiscal Court. The collaboration purchased and distributed masks, hand sanitizer, and disinfectant to 281 small businesses (less than 25 employees) that employed 1,800 people. We also delivered the necessities to 200 senior citizens and at-risk population.
- Established a Workforce Collaborative between the MCIF, Career Center, Marion County Area Technology Center, Elizabethtown Community & Technical College, and industry representatives to attract and train workforce. Marion County has 39 essential industries that

employ almost 10,000 people. We currently have over 400 job openings that we are working creatively to fill.

- Established a BAD (Brownfield, Abandoned, and Dilapidated) Building Initiative to eliminate slum and blight in Marion County.
- Designing and building a multiuse building and conference center on the Kentucky Bourbon Trail in our Crossroads Business Park.
- Developing roads and infrastructure to 250 acres in our Crossroads Business Park.

BUSINESS DEVELOPMENT CORP. OF THE NORTHERN PANHANDLE/WEIRTON, WV EXECUTIVE DIRECTOR, 2009 - SEPT. 2019

- Formed in 1993 and chartered as a 501-C3 (private, not for profit) organization, the BDC is the designated economic development organization for Brooke and Hancock counties. The BDC gets its support from the WV Development Office, WV Economic Development Authority, USEDA, USEPA, Hancock and Brooke Counties, and the cities of Weirton, Wellsburg, Beech Bottom, Bethany, and New Cumberland.
- Five existing economic development organizations in Brooke and Hancock Counties were consolidated to form a single organization dedicated to creating jobs and encouraging economic investment in WV's Northern Panhandle.
- Since 2009, the BDC has participated in the creation of approximately \$136 million in annual payroll. Actions have brought in more than \$603 million in private and public investment, created and preserved approximately 3,200 jobs, and have contributed to reducing the unemployment rate in Brooke and Hancock counties from over 13% to slightly over 5%. Strong partnerships with local, state, and federal officials have led to \$50 million of federal, state, local, and foundation financial assistance for projects and programs. Leading the metro area through an industrial renaissance that has the northern panhandle among the highest percentage increases in construction jobs in the country.
- Grew BDC's total assets from \$356,000 to \$9.4 million.
- Grew BDC's net income from \$36,000 to \$1.6 million.
- Reorganized the board and organization, created new bylaws, created a membership organization and membership fee structure, and a new board of directors diverse in geographic representation, industry representation, and public/private representation.
