

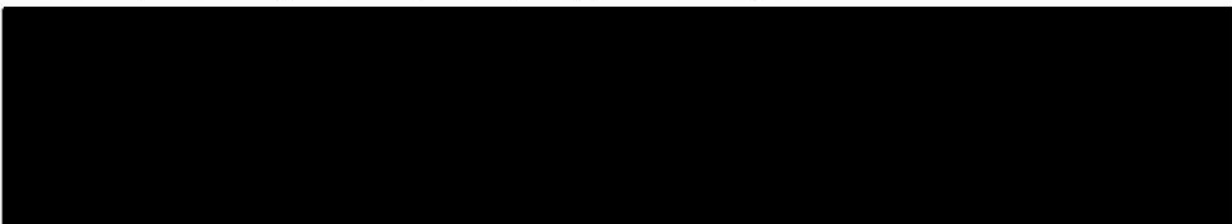
BUSINESS MEETING


Thursday, September 29, 2022

U.S. House of Representatives,  
Permanent Select Committee on Intelligence,  
Washington, D.C.

The committee met, pursuant to call, at 10:04 a.m., in Room HVC-304, Capitol Visitor Center, the Honorable Jim Himes presiding.

MR. HIMES: The business meeting will come to order.

Let me stress that we are in open session. My remarks will be entirely at the unclassified level. Discussion of any classified material will require us to move into closed session.

We have two very quick agenda items for this business meeting. First, I ask unanimous consent that sections 14(f)5(b) and 14(h)2(b) of the committee rules be waived for the purpose of today's briefing, given that our House Armed Services colleagues who are joining the engagement already have access to the classified information contained in the briefing.

Second, Representative Lamborn, the ranking member of the House Armed Services Committee Subcommittee on Strategic Forces, has requested access to today's briefing entitled, "Compartmented Briefing on Defense of the IC's Space Architecture."
