

**AMENDMENT TO THE AMENDMENT IN THE
NATURE OF A SUBSTITUTE TO H.R. 9624
OFFERED BY M__ . _____**

At the appropriate place, insert the following new
section:

1 **SEC. ____ . LIMITATION ON AVAILABILITY OF FUNDS FOR**
2 **THE OFFICE OF THE DIRECTOR OF NATIONAL**
3 **INTELLIGENCE PENDING SUBMISSION OF RE-**
4 **PORTS RELATED TO FOREIGN THREATS TO**
5 **FEDERAL ELECTIONS.**

6 Of the funds authorized to be appropriated by this
7 Act or otherwise made available for fiscal year 2027 for
8 the Office of the Director of National Intelligence, not
9 more than 90 percent may be obligated or expended until
10 the date on which the Director of National Intelligence
11 is in compliance with each of the following requirements
12 of the Damon Paul Nelson and Matthew Young Pollard
13 Intelligence Authorization Act for Fiscal Years 2018,
14 2019, and 2020 (division E of the National Defense Au-
15 thorization Act for Fiscal Year 2020):

16 (1) With respect to the Federal election of No-
17 vember 3, 2026—

1 (A) the requirement under subsection
2 (a)(1) of section 5304 of such Act (50 U.S.C.
3 3371) that the Director make publicly available
4 a report on foreign counterintelligence and cy-
5 bersecurity threats to campaigns of candidates
6 for Federal office with respect to such Federal
7 election, which was required to be made publicly
8 available not later than the date that is one
9 year before such election, and which was not
10 made publicly available by that date; and

11 (B) the requirement under subsection (b)
12 of section 6503 of such Act (50 U.S.C. 3371a)
13 that the Director submit to congressional lead-
14 ership and the appropriate congressional com-
15 mittees a report on security vulnerabilities of
16 State election systems and an assessment of
17 foreign intelligence threats with respect to such
18 Federal election, which was required to be sub-
19 mitted not later than 180 days before such elec-
20 tion, and which was not submitted by that date.

21 (2) With respect to the Federal election of No-
22 vember 5, 2024—

23 (A) the requirement under subsection
24 (c)(1) of section 5304 of such Act (50 U.S.C.
25 3371) that the Director conduct an assessment

1 of any information indicating that a foreign
2 government has acted with the intent or pur-
3 pose of interfering in elections for Federal of-
4 fice occurring during the Federal election cycle
5 ending with such Federal election and transmit
6 to Congress the findings of the Director with
7 respect to that assessment, which were required
8 to be transmitted not later than 45 days after
9 such election, and which were not transmitted
10 to Congress by such date; and

11 (B) the requirement under subsection
12 (c)(3) of section 5304 of such Act (50 U.S.C.
13 3371) that the Director make available to the
14 public the findings referred to in subparagraph
15 (A), which were required to be made available
16 to the public not later than 60 days after such
17 election, and which were not made available to
18 the public by such date.
