The United States of America; U.S. Department of Homeland Security; U.S. Customs and Border Protection; and Alan Bersin, in his official capacity as the Commissioner of U.S. Customs and Border Protection. The lawsuit was filed the United States Court of International Trade, Court No. 11-00511, and involves the exclusion of goods (certain coaxial cable connectors) from entry into the United States pursuant to a General Exclusion Order. The court had subject matter jurisdiction of the action pursuant to 28 U.S.C. § 1581(a). The court recently granted summary judgment to Corning Gilbert, Inc.
