I am a Professor of Environmental Law at Vermont Law School. Endangered species conservation is one of my areas of expertise. I have litigated many cases, taught many courses, published many articles, and testified numerous times on ESA matters. In 1991 I served as Special Counsel to the US Fish and Wildlife Service in the matter of the northern spotted owl exemption proceeding.
