

AMENDMENT IN THE NATURE OF A SUBSTITUTE
TO H. RES. 555
OFFERED BY MR. BISHOP OF UTAH

Strike all after the preamble and insert the following
new text:

1 *Resolved*, That the President is requested, and the
2 Secretary of the Interior is directed, to transmit, to the
3 extent that such documents are in the possession of the
4 President or the Secretary, (in a manner appropriate to
5 classified information, if the President determines appro-
6 priate) to the House of Representatives, not later than 14
7 days after the date of the adoption of this resolution, cop-
8 ies of every document, map, survey, report, record, memo-
9 randum, call log, correspondence (electronic and other-
10 wise), and other communication or any portion of any such
11 communication, that refers or relates to the executive
12 order on the review of designations under the Antiquities
13 Act (Executive Order 13792, April, 26, 2017), including
14 the following:

15 (1) All documents and communications relating
16 to the Secretary of the Interior's review of all Presi-
17 dential designations or expansions of designations

1 under the Antiquities Act made since January 1,
2 1996, as described in the executive order.

3 (2) All documents and communications relating
4 to the Secretary of the Interior's review of all Presi-
5 dential designations where the Secretary determined
6 that the designation or expansion was made without
7 adequate public outreach and coordination with rel-
8 evant stakeholders, as described in the executive
9 order.

10 (3) All documents and communications relating
11 to the interim and final reports to the President, in-
12 cluding any recommendations for Presidential ac-
13 tions, legislative proposals, or other actions rec-
14 ommended by the Secretary of the Interior to carry
15 out the policy set forth in section 1 of the executive
16 order.

17 (4) Any meeting or communication that oc-
18 curred between Secretary Ryan Zinke and President
19 Trump, or their representatives, relating to the rec-
20 ommendations or reports required by the executive
21 order.

22 (5) Any meeting or communication that oc-
23 curred between Secretary Ryan Zinke, or his rep-
24 resentatives, and energy and mining companies, or

1 their representatives, relating to the recommenda-
2 tions or reports required by the executive order.

3 (6) Any meeting or communication that oc-
4 curred between Secretary Ryan Zinke, or his rep-
5 resentatives, and LGBTQ and minority commu-
6 nities, or their representatives, relating to the rec-
7 ommendations or reports required by the executive
8 order.

9 (7) Any documents and communications relat-
10 ing to travel costs of Secretary Zinke and his staff
11 for the purposes of the review under the executive
12 order.

13 (8) Any meeting or communication that oc-
14 curred between Secretary Ryan Zinke, or his rep-
15 resentatives, and Native American tribes, or their
16 representatives, relating to the recommendations or
17 reports required by the executive order.

18 (9) Any document including applicable ethics
19 waivers for Department of the Interior employees
20 working on the review, as described in the executive
21 order, whether granted or denied.

22 (10) Any documents that, on their face, contain
23 economic analyses of national monument designa-
24 tions, as described in the executive order.
