Subject: Full Committee Markup Notice

The Committee on Natural Resources has scheduled a markup beginning on **Wednesday**, April **18**, **2018**, at **10:15** a.m. The Committee will consider the following bills:

- H.R. 788 (Rep. Duncan D. Hunter), To amend the Pittman-Robertson Wildlife Restoration Act to facilitate the establishment of additional or expanded public target ranges in certain States. *"Target Practice and Marksmanship Training Support Act"*;
- H.R. 1026 (Rep. Richard M. Nolan), To revise the authorized route of the North Country National Scenic Trail in northeastern Minnesota and to extend the trail into Vermont to connect with the Appalachian National Scenic Trail, and for other purposes. *"North Country National Scenic Trail Route Adjustment Act";*
- H.R. 1037 (Rep. Stephen F. Lynch), To authorize the National Emergency Medical Services Memorial Foundation to establish a commemorative work in the District of Columbia and its environs, and for other purposes;
- H.R. 2991 (Rep. Lloyd Smucker), To establish the Susquehanna National Heritage Area in the State of Pennsylvania, and for other purposes. *"Susquehanna National Heritage Area Act"*;
- H.R. 3400, (Rep. Rob Bishop), To promote innovative approaches to outdoor recreation on Federal land and to open up opportunities for collaboration with non-Federal partners, and for other purposes. "Recreation Not Red-Tape Act"; Amendments to H.R. 3400 must be drafted to the amendment in the nature of a substitute, attached to this notice.
- **H.R. 4069 (Rep. Don Young),** To amend the Migratory Bird Treaty Act to clarify the treatment of authentic Alaska Native articles of handicraft containing nonedible migratory bird parts, and for other purposes; and
- H.R. 4645 (Rep. Greg Gianforte), To amend the Wild and Scenic Rivers Act to designate certain segments of East Rosebud Creek in Carbon County, Montana, as components of the Wild and Scenic Rivers System. *"East Rosebud Wild and Scenic Rivers Act"*.
