

## COMMITTEE MARKUP ACTION

The Committee on Natural Resources met in open session on Tuesday, May 8, 2018, to consider the following bills:

**H.R. 221 (Rep. Don Young)**, To reauthorize the Hydrographic Services Improvement Act of 1998, and for other purposes. *“Hydrographic Services Improvement Amendments Act”*.

The Subcommittee on Water, Power and Oceans was discharged from further consideration of H.R. 221 by unanimous consent.

An amendment offered by Mr. Young of Alaska [#1], was agreed to by unanimous consent.

H.R. 221, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 1791 (Rep. David G. Reichert)**, To establish the Mountains to Sound Greenway National Heritage Area in the State of Washington, and for other purposes. *“Mountains to Sound Greenway National Heritage Act”*.

The Subcommittee on Federal Lands was discharged from further consideration of H.R. 1791 by unanimous consent.

An amendment offered by Mr. Bishop of Utah [#1], was agreed to by unanimous consent.

H.R. 1791, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 2591 (Rep. Austin Scott)**, To amend the Pittman-Robertson Wildlife Restoration Act to modernize the funding of wildlife conservation, and for other purposes. *“Modernizing the Pittman-Robertson Fund for Tomorrow's Needs Act of 2017”*.

The Subcommittee on Federal Lands was discharged from further consideration of H.R. 2591 by unanimous consent.

An amendment offered by Mr. Bishop of Utah [#1], was agreed to by unanimous consent.

H.R. 2591, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 3535 (Rep. Doug LaMalfa)**, To restore Federal recognition to the Ruffey Rancheria of California, and for other purposes. “*Ruffey Rancheria Restoration Act of 2017*”.

The Subcommittee on Indian, Insular and Alaska Native Affairs was discharged from further consideration of H.R. 3535 by unanimous consent.

An amendment in the nature of a substitute (ANS) offered by Mr. LaMalfa [051] was agreed to by voice vote.

H.R. 3535, as amended, was adopted and favorably reported to the House of Representatives by a roll call vote of 19 yeas and 18 nays.

**H.R. 4032 (Rep. Tom O’Halloran)**, To confirm undocumented Federal rights-of-way or easements on the Gila River Indian Reservation, clarify the northern boundary of the Gila River Indian Community's Reservation, to take certain land located in Maricopa County and Pinal County, Arizona, into trust for the benefit of the Gila River Indian Community, and for other purposes. “*Gila River Indian Community Federal Rights-of-Way, Easements and Boundary Clarification Act*”.

The Subcommittee on Indian, Insular and Alaska Native Affairs and the Subcommittee on Federal Lands were discharged from further consideration of H.R. 4032 by unanimous consent.

An amendment offered by Mr. Grijalva [086], was agreed to by unanimous consent.

H.R. 4032, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 4506 (Rep. Norma J. Torres)**, To provide incentives to encourage tribal job creation and economic activity, and for other purposes. “*Jobs for Tribes Act*”.

The Subcommittee on Indian, Insular and Alaska Native was discharged from further consideration of H.R. 4506 by unanimous consent.

An amendment offered by Mr. Grijalva [087], was agreed to by unanimous consent.

H.R. 4506, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 4689 (Rep. Adrian Smith)**, To authorize early repayment of obligations to the Bureau of Reclamation within the Northport Irrigation District in the State of Nebraska.

The Subcommittee on Water, Power and Oceans was discharged from further consideration of H.R. 4689 by unanimous consent.

H.R. 4689 was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 5317 (Rep. Jaime Herrera Beutler)**, To repeal section 2141 of the Revised Statutes to remove the prohibition on certain alcohol manufacturing on Indian lands.

The Subcommittee on Indian, Insular and Alaska Native was discharged from further consideration of H.R. 5317 by unanimous consent.

H.R. 5317 was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 5655 (Rep. Andy Barr)**, To establish the Camp Nelson Heritage National Monument in the State of Kentucky as a unit of the National Park System, and for other purposes. “*Camp Nelson Heritage National Monument Act*”.

H.R. 5655 was adopted and ordered favorably reported to the House of Representatives by unanimous consent.
