COMMITTEE MARKUP ACTION

The Committee on Natural Resources met in open session on Wednesday, July 11, 2018, to consider the following bills:

H.R. 577 (Rep. Dina Titus), To designate a peak in the State of Nevada as Maude Frazier Mountain.

The Subcommittee on Federal Lands was discharged from further consideration of H.R. 577 by unanimous consent.

H.R. 577 was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

H.R. 1482 (Rep. Michael K. Simpson), To authorize the Secretary of Agriculture to maintain or replace certain facilities and structures for commercial recreation services at Smith Gulch in Idaho, and for other purposes.

The Subcommittee on Federal Lands was discharged from further consideration of H.R. 1482 by unanimous consent.

H.R. 1482 was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

H.R. 3764 (**Rep. Greg Gianforte**), To extend the Federal recognition to the Little Shell Tribe of Chippewa Indians of Montana, and for other purposes. "Little Shell Tribe of Chippewa Indians Restoration Act of 2017".

The Subcommittee on Indian, Insular and Alaska Native Affairs was discharged from further consideration of H.R. 3764 by unanimous consent.

An amendment offered by Mr. Bishop of UT [#1], was agreed to by unanimous consent.

H.R. 3764, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

H.R. 5613 (**Rep. Kevin Yoder**), To designate the Quindaro Townsite in Kansas City, Kansas, as a National Historic Landmark, and for other purposes. "Quindaro Townsite National Historic Landmark Act".

The Subcommittee on Federal Lands was discharged from further consideration of H.R. 5613 by unanimous consent.

An amendment offered by Mr. Bishop of UT [#1], was agreed to by unanimous consent.

H.R. 5613, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

H.R. 6077 (Rep. Tom Reed), Recognizing the National Comedy Center in Jamestown, New York. "National Comedy Center Recognition Act".

The Subcommittee on Federal Lands was discharged from further consideration of H.R. 6077 by unanimous consent.

H.R. 6077 was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

H.R. 6302 (**Rep. Jack Bergman**), To enact as law certain regulations relating to the taking of double-crested cormorants.

An amendment offered by Mr. Bergman [#1], was agreed to by voice vote.

H.R. 6302, as amended, was adopted and ordered favorably reported by a roll call vote of 19 yeas and 13 nays.
