

Committee on Natural Resources - Markup Action

June 26, 2019

The Committee on Natural Resources met on Wednesday, June 26, 2019, and considered the following bills:

H.R. 823, *Colorado Outdoor Recreation and Economy Act*

Subcommittee on National Parks, Forests, and Public Lands and the Subcommittee on Energy and Mineral Resources were discharged from further consideration of H.R. 823 by unanimous consent.
