Committee on Natural Resources – Markup Action

The Committee on Natural Resources met on Wednesday, September 25, 2019, and considered the following bills. Copies of amendments and roll call sheets can be found at https://docs.house.gov/.

H.R. 729 (Rep. Kilmer), To amend the Coastal Zone Management Act of 1972 to authorize grants to Indian Tribes to further achievement of Tribal coastal zone objectives, and for other purposes. "Tribal Coastal Resiliency Act."

Subcommittee on Water, Oceans, and Wildlife and the Subcommittee for Indigenous Peoples of the United States were discharged from further consideration of H.R. 729 by unanimous consent.

- H.R. 729 was adopted and ordered favorably reported to the House of Representatives by voice vote.
- **H.R. 925** (Rep. Mike Thompson), To extend the authorization of appropriations for allocation to carry out approved wetlands conservation projects under the North American Wetlands Conservation Act through fiscal year 2024. "North American Wetlands Conservation Extension Act."

Subcommittee on Water, Oceans, and Wildlife was discharged from further consideration of H.R. 925 by unanimous consent.

- H.R. 925 was adopted and ordered favorably reported to the House of Representatives by a roll call vote of 26 yeas and 9 nays.
- **H.R. 1472** (Rep. Adrian Smith), To rename the Homestead National Monument of America near Beatrice, Nebraska, as the Homestead National Historic Park.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 1472 by unanimous consent.

- H.R. 1472 was adopted and ordered favorably reported to the House of Representatives by unanimous consent.
- **H.R. 1487** (Rep. Lieu), To direct the Secretary of the Interior to conduct a special resource study of portions of the Los Angeles coastal area in the State of California to evaluate alternatives for protecting the resources of the coastal area, and for other purposes. "Santa Monica Mountains National Recreation Area Boundary Adjustment Study Act."

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 1487 by unanimous consent.

- An amendment offered by Mr. Grijalva #1 was agreed to by unanimous consent.
- H.R. 1487, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

H.R. 1492 (Rep. Tipton), To update the map of, and modify the maximum acreage available for inclusion in, the Yucca House National Monument. "Yucca House National Monument Boundary Revision Act."

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 1492 by unanimous consent.

- An amendment in the nature of a substitute offered by Mr. Grijalva was agreed to by unanimous consent
- H.R. 1492, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.
- **H.R. 1747** (Rep. Wittman), To encourage partnerships among public agencies and other interested persons to promote fish conservation. "National Fish Habitat Conservation Through Partnerships Act."

Subcommittee on Water, Oceans, and Wildlife was discharged from further consideration of H.R. 1747 by unanimous consent.

- An amendment offered by Ms. González-Colón was agreed to by voice vote.
- H.R. 1747, as amended, was adopted and ordered favorably reported to the House of Representatives by voice vote.
- H.R. 2185 (Rep. Norton), To amend the Coastal Zone Management Act of 1972 to allow the District of Columbia to receive Federal funding under such Act, and for other purposes. "District of Columbia Flood Prevention Act of 2019."

Subcommittee on Water, Oceans, and Wildlife was discharged from further consideration of H.R. 2185 by unanimous consent.

- H.R. 2185 was adopted and ordered favorably reported to the House of Representatives by a roll call vote of 20 yeas and 15 nays.
- H.R. 3115 (Rep. Pallone), To direct the Administrator of the National Oceanic and Atmospheric Administration to make grants to State and local governments and nongovernmental organizations for purposes of carrying out climate-resilient living shoreline projects that protect coastal communities by supporting ecosystem functions and habitats with the use of natural materials and systems, and for other purposes. "Living Shorelines Act of 2019."

Subcommittee on Water, Oceans, and Wildlife was discharged from further consideration of H.R. 3115 by unanimous consent.

- An amendment offered by Mr. Cunningham and Mr. Graves #1 was agreed to by voice vote.
- H.R. 3115, as amended, was adopted and ordered favorably reported to the House of Representatives by a roll call vote of 22 yeas and 13 nays.

H.R. 3541 (Rep. Carbajal), To amend the Coastal Zone Management Act of 1972 to require the Secretary of Commerce to establish a coastal climate change adaptation preparedness and response program, and for other purposes. "Coastal State Climate Preparedness Act of 2019."

Subcommittee on Water, Oceans, and Wildlife was discharged from further consideration of H.R. 3541 by unanimous consent.

- H.R. 3541 was adopted and ordered favorably reported to the House of Representatives by a roll call vote of 20 yeas and 15 nays.
- **H.R. 3596** (Rep. Pingree), To amend the Coastal Zone Management Act of 1972 to establish a Working Waterfront Task Force and a working waterfronts grant program, and for other purposes. "Keep America's Waterfronts Working Act."

Subcommittee on Water, Oceans, and Wildlife was discharged from further consideration of H.R. 3596 by unanimous consent.

- An amendment offered by Mr. Cunningham and Mr. Graves #1 to the Grijalva amendment in the nature of a substitute was agreed to by voice vote.
- An amendment in the nature of a substitute offered by Mr. Grijalva, as amended, was agreed to by voice vote.
- H.R. 3596, as amended, was adopted and ordered favorably reported to the House of Representatives by a roll call vote of 22 yeas and 13 nays.
