

**AMENDMENT IN THE NATURE OF A SUBSTITUTE
TO H.R. 3250
OFFERED BY MR. GRIJALVA OF ARIZONA**

Strike all after the enacting clause and insert the following:

1 SECTION 1. SHORT TITLE.

2 This Act may be cited as the “Julius Rosenwald and
3 the Rosenwald Schools Act of 2019”.

**4 SEC. 2. RESOURCE STUDY OF JULIUS ROSENWALD AND
5 ROSENWALD SCHOOLS.**

6 (a) DEFINITIONS.—In this section:

7 (1) ROSENWALD SCHOOL.—The term “Rosen-
8 wald School” means any of the 5,357 schools and
9 related buildings constructed in 15 southern States
10 during the period of 1912 through 1932 by the phi-
11 lanthropy of Julius Rosenwald.

12 (2) SECRETARY.—The term “Secretary” means
13 the Secretary of the Interior.

14 (3) STUDY AREA.—The term “study area”
15 means the sites associated with the life and legacy
16 of Julius Rosenwald.

17 (b) SPECIAL RESOURCE STUDY.—

1 (1) STUDY.—The Secretary shall conduct a spe-
2 cial resource study of the study area, with a special
3 emphasis on the following Rosenwald Schools and
4 other sites associated with the life and legacy of Ju-
5 lius Rosenwald:

6 (A) Sears Administration Building at
7 Homan Square in Chicago, Illinois.

8 (B) Rosenwald Court Apartments in Chi-
9 cago, Illinois.

10 (C) Museum of Science & Industry in Chi-
11 cago, Illinois.

12 (D) Rosenwald House (formerly the Lyon
13 Home) at the Lincoln Home National Historic
14 Site in Springfield, Illinois.

15 (E) Cairo Rosenwald School, a one-teacher
16 school in Sumner County, Tennessee.

17 (F) Shady Grove School, a one-teacher
18 school in Louisa County, Virginia.

19 (G) Noble Hill School, a two-teacher school
20 in Bartow County, Georgia.

21 (H) Ridgeley School, a two-teacher school
22 in Prince Georges County, Maryland.

23 (I) Bay Springs School, a two-teacher
24 school in Forest County, Mississippi.

1 (J) Russell School, a two-teacher school in
2 Durham County, North Carolina.

3 (K) Shiloh Rosenwald School, a three-
4 teacher school in Macon County, Alabama;

5 (L) San Domingo School, a four-teacher
6 school in Wicomico County, Maryland.

7 (M) Elmore County Training School, a
8 seven-teacher school in Elmore County, Ala-
9 bama.

10 (N) Dunbar Junior High, Senior High and
11 Junior College in Little Rock, Arkansas.

12 (2) CONTENTS.—In conducting the study under
13 paragraph (1), the Secretary shall—

14 (A) evaluate the national significance of
15 the study area;

16 (B) determine the suitability and feasibility
17 of designating the study area as a unit of the
18 National Park System, including an interpretive
19 center in or near Chicago, Illinois;

20 (C) consider other alternatives for preser-
21 vation, protection, and interpretation of the
22 study area by the Federal Government, State or
23 local government entities, or private and non-
24 profit organizations;

1 (D) consult with interested Federal agen-
2 cies, State or local governmental entities, pri-
3 vate and nonprofit organizations, or any other
4 interested individuals; and

5 (E) identify cost estimates for any Federal
6 acquisition, development, interpretation, oper-
7 ation, and maintenance associated with the al-
8 ternatives.

9 (c) APPLICABLE LAW.—The study under paragraph
10 (1) shall be conducted in accordance with section 100507
11 of title 54, United States Code.

12 (d) RESULTS.—Not later than 3 years after the date
13 on which funds are first made available for the study
14 under paragraph (1), the Secretary shall submit to the
15 Committee on Natural Resources of the House of Rep-
16 resentatives and the Committee on Energy and Natural
17 Resources of the Senate a report describing—

18 (1) the results of the study; and

19 (2) any conclusions and recommendations of the
20 Secretary relating to the study.
