Page 1, line 3, insert “**ROUTE**” after “**TRAIL**”.

Page 1, strike lines 5 through 6 and insert the following:

1 (1) MAP.—The term “Map” means the map en-
2 titled “September 11th National Memorial Trail
3 Route Proposed Trail Route,” numbered _____,
4 and dated July 2021.

Page 2, strike lines 1 through 3.

Page 2, line 4, strike “(4)” and insert “(3)”.

Page 2, line 4, insert “**ROUTE**” after “**TRAIL**”.

Page 2, line 4, strike “term ‘Trail’” insert “term ‘Trail Route’”.

Page 2, line 8, strike “**AUTHORITY**” and insert “**DESIGNATION**”.

Page 2, line 8, strike “The Secretary,” and all that follows through “tour route, to be” on page 2, line 10, and insert: “There is designated a Trail Route, to be”.

Page 2, line 12, strike “September 11” and insert “9/11”.

Page 2, line 13, insert “National 9/11” before “Pen-”.

Page 2, line 17, insert “Route” after “Trail”.

Page 2, line 23, strike “Trail of Remembrance” and insert “trail of remembrance”.

Page 3, line 4, strike “its founding” and all that follows through page 3, line 6, and insert: “September 11, 2001”.

Page 3, line 7, strike “The Trail” and all that follows through page 4, line 10, and insert the following:

1 (A) IN GENERAL.—The Trail Route shall
2 consist of a series of trails as generally depicted
3 on the Map.

4 (B) AVAILABILITY OF MAP.—The Map
5 shall be available in the appropriate offices of
6 the National Park Service.

7 (C) REVISION.—The Secretary may revise
8 the Map by publication in the Federal Register
9 of a notice of availability of a new Map.
