

## Committee on Natural Resources – Markup Action Report (revised)

The Committee on Natural Resources met on Wednesday, July 14, 2021, to consider the following bills. Per Committee Rule 9(f)(1), roll call votes will be posted no later than 48 hours after the vote is taken. These documents and the amendments below can be found at docs.house.gov, found [here](#).

**[H.R. 820](#)** (Rep. LaHood), To establish the New Philadelphia National Historical Park in the State of Illinois as a unit of the National Park System, and for other purposes. *New Philadelphia National Historical Park Act*.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 820 by unanimous consent.

- Ranking Member Bruce Westerman (R-AR) offered an amendment designated Westerman #1. The amendment was agreed to by unanimous consent.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**[H.R. 972](#)** (Rep. Calvert), To provide for the establishment of the Western Riverside County Wildlife Refuge. *Wildlife Refuge Conservation and Recreation for the Community Act*.

Subcommittee on Water, Oceans, and Wildlife was discharged from further consideration of H.R. 972 by unanimous consent.

- The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**[H.R. 1154](#)** (Rep. McEachin), To authorize the Secretary of the Interior to conduct a study to assess the suitability and feasibility of designating certain land as the Great Dismal Swamp National Heritage Area, and for other purposes. *Great Dismal Swamp National Heritage Area Act*.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 1154 by unanimous consent.

- The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**[H.R. 1664](#)** (Rep. Veasey), To authorize the National Medal of Honor Museum Foundation to establish a commemorative work in the District of Columbia and its environs, and for other purposes.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 1664 by unanimous consent.

- The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**[H.R. 1908](#)** (Rep. Case), To authorize the Secretary of the Interior to conduct a study to assess the suitability and feasibility of designating certain land as the Ka'ena Point National Heritage Area, and for other purposes. *Ka'ena Point National Heritage Area Act*.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 1908 by unanimous consent.

- The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 2278](#) (Rep. Connolly), To authorize the Secretary of the Interior to designate the September 11th National Memorial Trail, and for other purposes.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 2278 by unanimous consent.

- Rep. Joe Neguse (D-CO) offered an amendment designated Neguse #50. The amendment was agreed to by unanimous consent.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 2444](#) (Rep. González-Colón), To establish Fort San Gerónimo del Boquerón in Puerto Rico as an affiliated area of the National Park System, and for other purposes. *Fort San Gerónimo Preservation Act*.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 2444 by unanimous consent.

- Rep. Jenniffer González-Colón (R-PR) offered an amendment designated González-Colón #1. The amendment was agreed to by unanimous consent.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 2497](#) (Rep. Neguse), To establish the Amache National Historic Site in the State of Colorado as a unit of the National Park System, and for other purposes. *Amache National Historic Site Act*.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 2497 by unanimous consent.

- Rep. Joe Neguse (D-CO) offered an amendment designated Neguse #49. The amendment was agreed to by unanimous consent.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 2780](#) (Rep. Grijalva), To provide for climate change planning, mitigation, adaptation, and resilience in the United States Territories and Freely Associated States, and for other purposes. *Insular Area Climate Change Act*.

- Chair Raúl M. Grijalva (D-AZ) offered an amendment designated Grijalva #1. The amendment was agreed to by voice vote.
- By unanimous consent, Rep. Cliff Bentz (R-OR) offered an amendment on behalf of Ranking Member Bruce Westerman (R-AR) designated Westerman #1. The amendment was not agreed to by a roll call vote of 19 yeas and 22 nays.

- By unanimous consent, Rep. Thomas P. Tiffany (R-WI) offered an amendment on behalf of Rep. Jay Obernolte (R-CA) designated Obernolte #1. The amendment was withdrawn.
- By unanimous consent, Rep. Garret Graves (R-LA) offered amendments designated Graves #1, Graves #2, and Graves #3 *en bloc*. The *en bloc* amendments were not agreed to by voice vote.
- By unanimous consent, Rep. Pete Stauber (R-MN) offered an amendment on behalf of Rep. Lauren Boebert (R-CO) designated Boebert #1. The amendment was not agreed to by a roll call vote of 19 yeas and 23 nays.
- Rep. Stauber offered an amendment designated Stauber #1. The amendment was not agreed to by a roll call vote of 18 and 23 nays.
- By unanimous consent, Rep. Blake Moore (R-UT) offered an amendment designated Westerman #2. The amendment was not agreed to by a roll call vote of 17 yeas and 25 nays.<sup>1</sup>
- Rep. Jenniffer González-Colón (R-PR) offered an amendment designated González-Colón #1. The amendment was not agreed to by a roll call vote of 20 yeas and 22 nays.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by a roll call vote of 25 yeas and 17 nays.

**H.R. 2899** (Rep. San Nicolas), To direct the Secretary of the Interior to conduct a study to assess the suitability and feasibility of designating areas within the island of Guam as a National Heritage Area, and for other purposes.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 2899 by unanimous consent.

- The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 3113** (Rep. Blake Moore), To require the Secretary of the Interior, the Secretary of Agriculture, and the Assistant Secretary of the Army for Civil Works to digitize and make publicly available geographic information system mapping data relating to public access to Federal land and waters for outdoor recreation, and for other purposes. *MAPLand Act*.

Subcommittee on National Parks, Forests, and Public Lands and the Subcommittee on Water, Oceans, and Wildlife were discharged from further consideration of H.R. 3113 by unanimous consent.

- Rep. Blake Moore (R-UT) offered an amendment designated Moore #1. The amendment was agreed to by unanimous consent.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 3616** (Rep. Blake Moore), To authorize the Secretary of the Interior to conduct a study to assess the suitability and feasibility of designating certain land as the Bear River National Heritage Area, and for other purposes. *Bear River National Heritage Area Study Act*.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 3616 by unanimous consent.

- The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 3764** (Rep. Grijalva), To direct the Administrator of the National Oceanic and Atmospheric Administration to provide for ocean-based climate solutions to reduce carbon emissions and global warming; to make coastal communities more resilient; and to provide for the conservation and restoration of ocean and coastal habitats, biodiversity, and marine mammal and fish populations; and for other purposes. *Ocean-Based Climate Solutions Act of 2021.*

- Chair Raúl M. Grijalva (D-AZ) offered an amendment in the nature of a substitute.
- Rep. Jared Huffman (D-CA) offered an amendment designated Huffman #1 to the amendment in the nature of a substitute. The amendment was agreed to by voice vote.
- Rep. Yvette Herrell (R-NM) offered an amendment designated Herrell #1 to the amendment in the nature of a substitute. The amendment was not agreed to by a roll call vote of 17 yeas and 20 nays.
- Rep. Jay Obernolte (R-CA) offered an amendment designated Obernolte #1 to the amendment in the nature of a substitute. The amendment was not agreed to by a roll call vote of 17 yeas and 20 nays.
- By unanimous consent, Rep. Pete Stauber (R-MN) offered an amendment on behalf of Rep. Lauren Boebert (R-CO) designated Boebert #1 to the amendment in the nature of a substitute. The amendment was not agreed to by a roll call vote of 19 yeas and 21 nays.
- Rep. Thomas P. Tiffany (R-WI) offered an amendment designated Tiffany #1 to the amendment in the nature of a substitute. The amendment was not agreed to by a roll call vote of 19 yeas and 22 nays.
- Rep. Paul Tonko (D-NY) offered an amendment designated Tonko #1 to the amendment in the nature of a substitute. The amendment was agreed to by voice vote. A recorded vote was requested. By unanimous consent, the request for a recorded vote was withdrawn and the amendment was considered agreed to by the previous voice vote.

- Rep. Graves offered an amendment designated Graves #7 to the amendment in the nature of a substitute. The amendment was agreed to by unanimous consent.
- Rep. Graves offered an amendment designated Graves #8 to the amendment in the nature of a substitute. The amendment was withdrawn.
- Rep. Graves offered an amendment designated Graves #9 to the amendment in the nature of a substitute. The amendment was not agreed to by voice vote.
- Rep. Graves offered an amendment designated Graves #11 to the amendment in the nature of a substitute. The amendment was withdrawn.
- By unanimous consent, Rep. Graves offered amendments designated Graves #12, Graves #14, and Graves #18 *en bloc*. The *en bloc* amendments were agreed to by unanimous consent.
- Rep. Graves offered an amendment designated Graves #13 to the amendment in the nature of a substitute. The amendment was not agreed to by a roll call vote of 18 yeas and 23 nays.
- By unanimous consent, Rep. Graves offered amendments designated Graves #15 and Graves #17 *en bloc*. The *en bloc* amendments were not agreed to by voice vote.
- Rep. Graves offered an amendment designated Graves #19 to the amendment in the nature of a substitute. The amendment was withdrawn.
- Rep. Russ Fulcher (R-ID) offered an amendment designated Fulcher #1 to the amendment in the nature of a substitute. The amendment was not agreed to by a roll call vote of 18 yeas and 22 nays.
- Rep. Rosendale offered an amendment designated Rosendale #2 to the amendment in the nature of a substitute. The amendment was not agreed to by a roll call vote of 18 yeas and 23 nays.
- The amendment in the nature of a substitute offered by Chair Grijalva, as amended, was agreed to by voice vote.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by a roll call vote of 23 yeas and 19 nays.

**H.R. 4300** (Rep. Miller-Meeks), To direct the Secretary of the Interior to make free National Parks and Federal Recreational Lands Passes available to members of the Armed Forces, and for other purposes. *Veterans in Parks (VIP) Act*.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 4300 by unanimous consent.

- Chair Raúl M. Grijalva (D-AZ) offered an amendment designated Grijalva-Westerman #1. The amendment was agreed to by unanimous consent
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.
