Page 51, line 14, strike section, insert –

In addition to amounts otherwise available, there is appropriated to the National Oceanic and Atmospheric Administration for fiscal year 2022, out of any money in the Treasury not otherwise appropriated, \$120,000,000 to remain available until September 30, 2026 to carry out purposes authorized under the Modernizing Recreational Fisheries Management Act of 2018.

Page 69, line 2, insert –

No provision of this section shall take effect until the Secretary has made the determination, in consultation with the Secretary of Energy, that

- b) reduced supply from the United States will not result in increased global reliance on oil and natural gas developed by Iran; and
- c) reduced supply from the United State will not result in an increase in the global average lifecycle emissions of global oil and natural gas supply, thus increased climate change risk because of increased global emissions.”

Page 69, line 20, insert –

No provision of this section shall take effect until the Secretary has made the determination, in consultation with the Secretary of Energy, that

- b) reduced supply from the United States will not result in increased global reliance on oil and natural gas developed by Iran; and
- c) reduced supply from the United State will not result in an increase in the global average lifecycle emissions of global oil and natural gas supply, thus increased climate change risk because of increased global emissions.”

P.60 line 20, insert –

This provision is suspended until such time that California no longer imports oil from any foreign nation where lifecycle greenhouse gas emissions associated with the imports are higher than if supplied by a domestic source.

P.70, line 6, insert –

Within 120 days of this section becoming law, the General Accountability Office shall issue a report on expected increase in energy prices, specifically gas prices at the pump, projected as a result of this provision.

P. 71, line 11 insert –

30 days after this section is enacted, the Secretary shall issue a report to the committee on whether the provisions contained in the section increased the need of the Nord Stream 2 pipeline to supply European nations.

P. 77, line 23, insert –

This provision is suspended until the Secretary has made a determination, in consultation with the Secretary of Energy, that the provision will not result in job loss or reduced income in majority minority communities.

P. 88, line 9, insert –

“provisions (l), (m), (n), (o), (p), (q), and (r) are suspended until the Secretary has made a determination, in consultation with the Secretary of HHS, that the provision will not result in loss of healthcare for any American.”

provisions (l), (m), (n), (o), (p), (q), and (r) are suspended until the Secretary has a made a determination, in consultation with the Secretary of Energy, that the provision will not result in increased unemployment of women.

P. 88, line 9, insert –

provisions (l), (m), (n), (o), (p), (q), and (r)) are suspended until such time that California no longer imports oil from any foreign nation that does not provide the same rights and privileges to women as the United States.

P. 88, line 9, insert –

provisions (l), (m), (n), (o), (p), (q), and (r) are suspended until there are two consecutive years where Russia does not export natural gas to any state in New England.

**Amendment to the Amendment in the Nature of a Substitute
Offered by Mr. Graves of Louisiana**

P. 88, line 9, insert –

provisions (l), (m), (n), (o), (p), (q), and (r) are suspended until the Secretary has made a determination, in consultation with the Secretary of Energy, that the provision will not result in increased risk of climate change impacts as a result of higher global emissions associated with alternative non-American supply of energy resources to meet global demand. In making such determination the Secretary, in consultation with the Secretary of Energy, shall conduct analysis of

- a) projected global demand for oil and natural gas through 2050
- b) lifecycle greenhouse gas emissions of the projected supply of oil and gas
- c) if the average lifecycle greenhouse gas emissions of any of the projected global supply of oil and gas is higher or lower than the lifecycle greenhouse gas emissions that would have occurred from the supply impacted by this provision

P. 88, line 9, insert –

provisions (l), (m), (n), (o), (p), (q), and (r) are suspended until the Secretary has made a determination, in consultation with the Secretary of Energy, that the provision will not result in increased global methane emissions as a result of shifting supply development to countries that produce and transport oil or natural gas with a higher lifecycle methane profile than in the United States.

**Amendment to the Amendment in the Nature of a Substitute
Offered by Mr. Graves of Louisiana**

P. 88, line 9, insert –

provisions (l), (m), (n), (o), (p), (q), and (r) shall be suspended by the Secretary if a determination is made that the impact of this section would result in direct or indirect higher lifecycle global greenhouse gas emissions consistent with increased risk identified by the Intergovernmental Panel on Climate Change (IPCC).
