## **Committee on Natural Resources – Markup Action Report**

The Committee on Natural Resources met on Wednesday, January 19, 2022, to consider the following measures. Per Committee Rule 9(f)(1), roll call votes will be posted no later than 48 hours after the vote is taken. These documents and the amendments below can be found at docs.house.gov, found <u>here.</u>

**H.R. 268** (Rep. Vela), To provide for the boundary of the Palo Alto Battlefield National Historic Park to be adjusted, to authorize the donation of land to the United States for addition to that historic park, and for other purposes.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 268 by unanimous consent.

- Chair Raúl M. Grijalva (D-AZ) offered an amendment in the nature of a substitute.
- The Grijalva amendment in the nature of a substitute was agreed to by unanimous consent.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 441** (Rep. Young), To provide for the conveyance of certain property to the Tanana Tribal Council located in Tanana, Alaska, and for other purposes.

Subcommittee for Indigenous Peoples of the United States was discharged from further consideration of H.R. 441 by unanimous consent.

• The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 1415** (Rep. Kilmer), To amend the Coastal Zone Management Act of 1972 to authorize grants to Indian Tribes to further achievement of Tribal coastal zone objectives, and for other purposes. *Tribal Coastal Resiliency Act*.

Subcommittee on Water, Oceans, and Wildlife, and Subcommittee for Indigenous Peoples of the United States, were discharged from further consideration of H.R. 1415 by unanimous consent.

- Chair Raúl M. Grijalva (D-AZ) offered an amendment in the nature of a substitute.
- Ranking Member Bruce Westerman (R-AR) offered an amendment designated Westerman #3 to the amendment in the nature of a substitute. The amendment was not agreed to by voice vote.
- The amendment in the nature of a substitute was agreed to by voice vote.

• The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by a roll call vote of 24 yeas and 16 nays.

**H.R. 2512** (Rep. Estes), To amend the National Trails System Act to designate the Chisholm National Historic Trail and the Western National Historic Trail, and for other purposes. *Chisholm National Historic Trail and Western National Historic Trail Designation Act.* 

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 2512 by unanimous consent.

• The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 2551** (Rep. Curtis), To designate and adjust certain lands in the State of Utah as components of the National Wilderness Preservation System, and for other purposes. *Bonneville Shoreline Trail Advancement Act.* 

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 2551 by unanimous consent.

• The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 2773** (Rep. Dingell), To amend the Pittman-Robertson Wildlife Restoration Act to make supplemental funds available for management of fish and wildlife species of greatest conservation need as determined by State fish and wildlife agencies, and for other purposes. *Recovering America's Wildlife Act of 2021*.

Subcommittee for Indigenous Peoples of the United States, and the Subcommittee on Water, Oceans, and Wildlife were discharged from further consideration of H.R. 2773 by unanimous consent.

- Chair Raúl M. Grijalva (D-AZ) offered an amendment in the nature of a substitute.
- Rep. Russ Fulcher (R-ID) offered an amendment designated Fulcher #14 to the amendment in the nature of a substitute. The amendment was not agreed to by a roll call vote of 17 yeas and 25 nays.<sup>1</sup>
- Rep. Fulcher offered an amendment designated Fulcher #15 to the amendment in the nature of a substitute. The amendment was not agreed to by a roll call vote of 18 yeas and 25 nays.

- Rep. Lauren Boebert (R-CO) offered an amendment designated Boebert #2 to the amendment in the nature of a substitute. The amendment was not agreed to by a roll call vote of 19 yeas and 25 nays.
- Ranking Member Bruce Westerman (R-AR) offered an amendment designated Westerman #5 to the amendment in the nature of a substitute. The amendment was not agreed to by a roll call vote of 17 yeas and 25 nays.
- Rep. Debbie Dingell (D-MI) offered an amendment designated Dingell #204 to the amendment in the nature of a substitute. The amendment was agreed to by voice vote.
- Rep. Tom Tiffany (R-WI) offered an amendment designated Tiffany #03 to the amendment in the nature of a substitute. The amendment was agreed to by voice vote.
- Ranking Member Westerman offered an amendment designated Westerman #6 to the amendment in the nature of a substitute. The amendment was not agreed to by voice vote.
- Ranking Member Westerman offered an amendment designated Westerman #7 to the amendment in the nature of a substitute. The amendment was not agreed to by a roll call vote of 17 yeas and 25 nays.
- Rep. Yvette Herrell (R-NM) offered an amendment designated Herrell #2773\_ESA to the amendment in the nature of a substitute. The amendment was not agreed to by voice vote.
- The amendment in the nature of a substitute, as amended, was agreed to by voice vote.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by a roll call vote 29 yeas and 15 nays.

**H.R. 2793** (Rep. Sean Patrick Maloney), To reauthorize the Highlands Conservation Act, to authorize States to use funds from that Act for administrative purposes, and for other purposes. *Highlands Conservation Reauthorization Act of 2021*.

Subcommittee on Water, Oceans, and Wildlife was discharged from further consideration of H.R. 2793 by unanimous consent.

- Chair Raúl M. Grijalva (D-AZ) offered an amendment. The amendment was agreed to by unanimous consent.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 2872** (Rep. Cartwright), To establish an integrated national approach to respond to ongoing and expected effects of extreme weather and climate change by protecting, managing, and conserving the fish, wildlife, and plants of the United States, and to maximize Government efficiency and reduce costs, in cooperation with State, local, and Tribal Governments and other entities, and for other purposes. *SAFE Act*; or, *Safeguarding America's Future and Environment Act*.

Subcommittee on Energy and Minerals Resources, Subcommittee for Indigenous Peoples of the United States, Subcommittee on National Parks, Forests, and Public Lands, and Subcommittee on Water, Oceans, and Wildlife, were discharged from further consideration of H.R. 2872 by unanimous consent.

- Rep. Blake Moore (R-UT) offered an amendment designated Moore #1. The amendment was not agreed to by a roll call vote of 17 yeas and 24 nays.
- Rep. Garret Graves (R-LA) offered an amendment designated Graves #2. The amendment was not agreed to by voice vote.
- Rep. Graves offered an amendment designated Graves #3. The amendment was not agreed to by voice vote.
- The bill was adopted and ordered favorably reported to the House of Representatives by a roll call vote of 23 yeas and 18 nays.

**H.R. 3228** (Rep. Velázquez), To direct the Secretary of Commerce, acting through the Administrator of the National Oceanic and Atmospheric Administration, to improve science, data, and services that enable sound decision making in response to coastal flood risk, including impacts of sea level rise, storm events, changing Great Lakes water levels, and land subsidence. *National Coastal Resilience Data and Services Act.* 

Subcommittee on Water, Oceans, and Wildlife was discharged from further consideration of H.R. 3228 by unanimous consent.

• Chair Raúl M. Grijalva (D-AZ) offered an amendment in the nature of a substitute.

- By unanimous consent, Rep. Garret Graves (R-LA) offered amendments designated Graves #4, Graves #5, and Graves #6 *en bloc* to the amendment in the nature of a substitute. The *en bloc* amendments were agreed to by unanimous consent.
- The Grijalva amendment in the nature of a substitute, as amended, was agreed to by voice vote.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by voice vote.

**H.R. 4009** (Rep. Norton), To authorize the Georgetown African American Historic Landmark Project and Tour to establish a commemorative work in the District of Columbia and its environs, and for other purposes. *Georgetown Waterfront Enslaved Voyages Memorial Act.* 

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 4009 by unanimous consent.

- Chair Raúl M. Grijalva (D-AZ) offered an amendment designated Grijalva #072. The amendment was agreed to by unanimous consent.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 4358** (Rep. Buchanan), To amend the Wild and Scenic Rivers Act to designate segments of the Little Manatee River as a component of the Wild and Scenic Rivers System, and for other purposes. *Little Manatee Wild and Scenic River Act.* 

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 4358 by unanimous consent.

- Chair Raúl M. Grijalva (D-AZ) offered an amendment in the nature of a substitute.
- Ranking Member Bruce Westerman (R-AR) offered an amendment designated Westerman #1 to the amendment in the nature of a substitute. The amendment was agreed to by unanimous consent.

- The bill, as amended, was adopted and favorably reported to the House of Representatives by unanimous consent.

**H.R. 4380** (Rep. Escobar), To designate the El Paso Community Healing Garden National Memorial, and for other purposes.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 4380 by unanimous consent.

• The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

**H.R. 4404** (Rep. Soto), To amend the Wild and Scenic Rivers Act to designate segments of the Kissimmee River in the State of Florida as a component of the Wild and Scenic Rivers System, and for other purposes. *Kissimmee River Wild and Scenic River Act*.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 4404 by unanimous consent.

**H.R. 5118** (Rep. Neguse), To direct the Secretary of Agriculture to prioritize the completion of the Continental Divide National Scenic Trail, and for other purposes. *Continental Divide Trail Completion Act.* 

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 5118 by unanimous consent.

- Rep. Joe Neguse (D-CO) offered an amendment in the nature of a substitute.
- The Neguse amendment in the nature of a substitute was agreed to by voice vote.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by voice vote.
