

Committee on Natural Resources – Markup Action Report (revised)

The Committee on Natural Resources met on Wednesday, June 15, 2022, to consider the following measures. Per Committee Rule 9(f)(1), roll call votes will be posted no later than 48 hours after the vote is taken. These documents and the amendments below can be found at docs.house.gov, found [here](#).

[H.R. 263](#) (Rep. Mike Quigley), To amend the Lacey Act Amendments of 1981 to clarify provisions enacted by the Captive Wildlife Safety Act, to further the conservation of certain wildlife species, and for other purposes. *Big Cat Public Safety Act*.

Subcommittee on Water, Oceans, and Wildlife was discharged from further consideration of H.R. 263 by unanimous consent.

- Chair Raúl M. Grijalva (D-AZ) previously offered an amendment in the nature of a substitute.
- Ranking Member Bruce Westerman (R-AR) previously offered a substitute amendment designated Westerman #077 to the amendment in the nature of a substitute.
- Rep. Lauren Boebert (R-CO) previously offered a substitute amendment designated Boebert #1 to the amendment in the nature of a substitute.
- Rep. Garret Graves (R-LA) previously offered an amendment designated Graves #2 to the amendment in the nature of a substitute.
- Rep. Graves previously offered an amendment designated Graves #3 to the amendment in the nature of a substitute.
- Rep. Graves offered an amendment designated Graves #4 to the amendment in the nature of a substitute.
- Chair Grijalva offered a motion to move the previous question on the Grijalva amendment in the nature of a substitute. The motion was agreed to by voice vote.
- The substitute amendment designated Westerman #077 was not agreed to by a roll call vote of 17 yeas and 24 nays.¹
- The substitute amendment designated Boebert #1 not agreed to by a roll call vote of 16 yeas and 22 nays.
- The amendment designated Graves #2 was not agreed to by a roll call vote of 14 yeas and 24 nays.
- The amendment designated Graves #3 was not agreed to by a roll call vote of 16 yeas and 24 nays.
- The amendment designated Graves #4 was not agreed to by a roll call vote of 16 yeas and 25 nays.
- The amendment in the nature of a substitute was agreed to by voice vote.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by a roll call vote of 25 yeas and 17 nays.

[H.R. 5444](#) (Rep. Sharice Davids), To establish the Truth and Healing Commission on Indian Boarding School Policies in the United States, and for other purposes. *Truth and Healing Commission on Indian Boarding School Policies Act.*

Subcommittee for Indigenous Peoples of the United States was discharged from further consideration of H.R. 5444 by unanimous consent.

- Chair Grijalva offered an amendment in the nature of a substitute.
- Ranking Member Westerman offered an amendment designated Westerman #2 to the amendment in the nature of a substitute. The amendment was agreed to by unanimous consent.
- Rep. Jay Obernolte (R-CA) offered an amendment designated Obernolte #3 to the amendment in the nature of a substitute. The amendment was not agreed to by a roll call vote of 18 yeas and 25 nays.
- Ranking Member Westerman offered an amendment designated Westerman #1 to the amendment in the nature of a substitute. The amendment was not agreed to by a roll call vote of 18 yeas and 25 nays.
- Rep. Boebert offered an amendment designated Boebert #1 to the amendment in the nature of a substitute. The amendment was not agreed to by a roll call vote of 17 yeas and 25 nays.
- The amendment in the nature of a substitute, as amended, was agreed to by voice vote.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by voice vote.

[H.R. 6063](#) (Rep. Betty McCollum), To provide for the equitable settlement of certain Indian land disputes regarding land in Illinois, and for other purposes.

Subcommittee for Indigenous Peoples of the United States was discharged from further consideration of H.R. 6063 by unanimous consent.

- Rep. Betty McCollum (D-MN) offered an amendment in the nature of a substitute. The amendment in the nature of a substitute was agreed to by voice vote.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by voice vote.

[H.R. 6181](#) (Rep. Ruben Gallego), To reaffirm that certain land has been taken into trust for the benefit of the Samish Indian Nation, and for other purposes. *Samish Indian Nation Land Reaffirmation Act.*

Subcommittee for Indigenous Peoples of the United States was discharged from further consideration of H.R. 6181 by unanimous consent.

- Rep. Ruben Gallego (D-AZ) offered an amendment in the nature of a substitute. The amendment in the nature of a substitute was agreed to by voice vote.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by a roll call vote of 24 yeas and 18 nays.

[H.R. 6337](#) (Rep. Joe Neguse), To require the Secretary of the Interior and the Secretary of Agriculture to develop long-distance bike trails on Federal land, and for other purposes. *Biking on Long-Distance Trails Act*.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 6337 by unanimous consent.

- Rep. Joe Neguse (D-CO) offered an amendment in the nature of a substitute. The amendment in the nature of a substitute was agreed to by unanimous consent.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 6707](#) (Rep. Jared F. Golden), To amend the Maine Indian Claims Settlement Act of 1980 to advance equality for Wabanaki nations, and for other purposes. *Advancing Equality for Wabanaki Nations Act*.

Subcommittee for Indigenous Peoples of the United States was discharged from further consideration of H.R. 6707 by unanimous consent.

- Chair Grijalva offered an amendment in the nature of a substitute.
- Rep. Obernolte offered an amendment designated Obernolte #1 to the amendment in the nature of a substitute. The amendment was not agreed to by voice vote.
- Rep. Obernolte offered an amendment designated Obernolte #2 to the amendment in the nature of a substitute. The amendment was not agreed to by a roll call vote of 18 yeas and 24 nays.
- The amendment in the nature of a substitute was agreed to by voice vote.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by a roll call vote of 24 yeas and 17 nays.

[H.R. 6734](#) (Rep. Hakeem S. Jeffries), To amend the Fish and Wildlife Act of 1956 to reauthorize the volunteer services, community partnership, and refuge education programs of the National Wildlife Refuge System, and for other purposes. *Keep America's Refuges Operational Act of 2022*.

Subcommittee on Water, Oceans, and Wildlife was discharged from further consideration of H.R. 6734 by unanimous consent.

- The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 7002](#) (Rep. Ann Wagner), To authorize the Gateway Arch in St. Louis, Missouri, to be illuminated by blue and yellow lights in support of Ukraine. *Gateway Solidarity Act*.

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 7002 by unanimous consent.

- Ranking Member Westerman offered an amendment designated Westerman #1. The amendment was agreed to by unanimous consent.
- The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 7025](#) (Rep. Raúl M. Grijalva), To prohibit the Director of the United States Fish and Wildlife Service from funding entities that commit, fund, or support gross violations of internationally recognized human rights, and for other purposes. *Advancing Human Rights-Centered International Conservation Act of 2022.*

Subcommittee on Water, Oceans, and Wildlife was discharged from further consideration of H.R. 7025 by unanimous consent.

- Chair Grijalva offered an amendment designated Grijalva #1. The amendment was agreed to by unanimous consent.
- The bill, as amended, was adopted and ordered favorably reported to the House of Representatives by unanimous consent.

[H.R. 7075](#) (Rep. Victoria Spartz), To designate Ukrainian Independence Park in Washington, District of Columbia, and for other purposes. *Ukrainian Independence Park Act of 2022.*

Subcommittee on National Parks, Forests, and Public Lands was discharged from further consideration of H.R. 7075 by unanimous consent.

- Ranking Member Westerman offered an amendment designated Westerman #078. The amendment was agreed to by unanimous consent.
- The bill, as amended, was ordered favorably reported to the House of Representatives by unanimous consent.

[S. 789](#) (Sen. Mike Rounds), A bill to repeal certain obsolete laws relating to Indians. *RESPECT Act or Repealing Existing Substandard Provisions Encouraging Conciliation with Tribes Act.*

Subcommittee for Indigenous Peoples of the United States was discharged from further consideration of S. 789 by unanimous consent.

- The bill was adopted and ordered favorably reported to the House of Representatives by unanimous consent.
