On Wednesday, July 20, 2022, at 10:00 a.m. ET in 1324 Longworth Hearing Room, via Webex, and livestreamed on the Committee's <u>YouTube</u> page, the Committee on Natural Resources will meet to consider the following bills:

- <u>H.R. 6353</u> (Rep. Susan Wild), To authorize the National Service Animals Monument Corporation to establish a commemorative work in the District of Columbia and its environs, and for other purposes. *National Service Animals Memorial Act.*
- <u>H.R. 6438</u> (Rep. Ken Buck), To authorize the Secretary of the Interior to conduct a special resource study of the site known as "Dearfield" in the State of Colorado. *Dearfield Study Act.*
- <u>H.R. 6799</u> (Rep. Brad R. Wenstrup), To direct the Secretary of the Interior to conduct a special resource study to determine the suitability and feasibility of establishing the John P. Parker House in Ripley, Ohio, as a unit of the National Park System. *John P. Parker House Study Act.*
- <u>H.R. 7618</u> (Rep. Shontel M. Brown), To designate the Kol Israel Foundation Holocaust Memorial in Bedford Heights, Ohio, as a national memorial.
- H.R. 8393 (Chair Raúl M. Grijalva), To enable the people of Puerto Rico to choose a permanent, nonterritorial, fully self-governing political status for Puerto Rico and to provide for a transition to and the implementation of that permanent, nonterritorial, fully self-governing political status, and for other purposes. *Puerto Rico Status Act. Amendments to HR 8393 must be drafted to the amendment in the nature of a substitute, attached to this notice.*

Note that all amendments filed by this time will be given priority recognition at the markup.
