- **[H.Res. 1247](#)** (Rep. Garret Graves) Of inquiry directing the Secretary of the Interior to transmit certain documents to the House of Representatives relating to the 2023-2028 five-year program for offshore oil and gas leasing. *Amendments to H.Res. 1247 must be drafted to the amendment in the nature of a substitute, attached to this notice.*
- **[H.Res. 1248](#)** (Rep. Yvette Herrell) Of inquiry directing the Secretary of the Interior to transmit certain documents to the House of Representatives relating to the compliance with the obligations of the Mineral Leasing Act. *Amendments to H.Res. 1248 must be drafted to the amendment in the nature of a substitute, attached to this notice.*
- **[H.Res. 1251](#)** (Rep. Pete Stauber) Of inquiry directing the Secretary of Agriculture to transmit certain documents to the House of Representatives relating to the mineral withdrawal within the Superior National Forest. *Amendments to H.Res. 1251 must be drafted to the amendment in the nature of a substitute, attached to this notice.*
- **[H.Res. 1252](#)** (Rep. Pete Stauber) Of inquiry directing the Secretary of the Interior to transmit certain documents to the House of Representatives relating to the mineral withdrawal within the Superior National Forest. *Amendments to H.Res. 1252 must be drafted to the amendment in the nature of a substitute, attached to this notice.*
- **[H.Res. 1253](#)** (Ranking Member Bruce Westerman) Of inquiry directing the Secretary of the Interior to transmit certain documents to the House of Representatives relating to the actions of the Department of the Interior's Departmental Ethics Office. *Amendments to H.Res. 1253 must be drafted to the amendment in the nature of a substitute, attached to this notice.*

Note that all amendments filed by this time will be given priority recognition at the markup. Amendments filed after the deadline or during the markup must also be filed electronically at HNRCdocs@mail.house.gov.

The Chair may roll votes on amendments and final passage of a measure; however, procedural votes may occur at any time and must be disposed of in real time. Bill text and amendments in the
