

COMMITTEE ON NATURAL RESOURCES -- ACTION REPORT

H.R. 1121 (Rep. Duncan), “*Protecting American Energy Production Act*”

The Subcommittee on Energy and Mineral Resources was discharged from further consideration of H.R. 1121.

- Representative Sydney Kamlager-Dove (D-CA) offered an amendment designated Kamlager-Dove #1.
The amendment was not adopted by roll call vote of **18 to 20**.
- Representative Mike Levin (D-CA) offered an amendment designated Levin_050.
The amendment was not adopted by roll call vote of **18 to 20**.

H.R. 1121 was ordered favorably reported to the House of Representatives by roll call vote of **21 to 17**.

H.R. 6008 (Rep. Graves of Louisiana), “*Requiring Integrity in Conservation Efforts Act*” or the “*R.I.C.E.’s Whale Act*”.

- Representative Garret Graves (R-LA) offered an amendment in the nature of a substitute designated Graves_084 ANS.
The amendment in the nature of a substitute was adopted by **voice vote**.
- Representative Raul Grijalva (D-AZ) offered an amendment to the amendment in the nature of a substitute designated Grijalva #1.
The amendment was not adopted by roll call vote of **18 to 20**.
- Representative Jared Huffman (D-CA) offered an amendment to the amendment in the nature of a substitute designated Huffman #2.
The amendment was not adopted by roll call vote of **18 to 21**.
- Representative Jared Huffman (D-CA) offered an amendment to the amendment in the nature of a substitute designated Huffman #3.
The amendment was not adopted by roll call vote of **18 to 21**.
- Representative Katie Porter (D-CA) offered an amendment to the amendment in the nature of a substitute designated Porter #4.
The amendment was not adopted by roll call vote of **18 to 21**.

H.R. 6008, as amended, was ordered favorably reported to the House of Representatives by roll call vote of **22 to 17**.

H.R. 4385 (Rep. Neguse), *“Drought Preparedness Act”*
