

## COMMITTEE ON NATURAL RESOURCES -- ACTION REPORT

The Committee on Natural Resources met in open session on Tuesday, February 6, 2024, to consider the following measures. **H.R. 1829** (Rep. Crane), To require the Secretary of Agriculture to convey the Pleasant Valley Ranger District Administrative Site to Gila County, Arizona.

The Subcommittee on Federal Lands was discharged from further consideration of H.R. 1829.
