I, Doreen Leavitt, Inupiat Community of the Arctic Slope Tribal Council Secretary, and the Director of Natural Resources, am requesting the Nuiqsut Public Meeting on the NPR-A Proposed Rule currently scheduled for Friday, October 13, 2023 be rescheduled to a later date. Eleven days notice for a public meeting is not sufficient for our community to prepare to share comments and questions on an issue that could have long-term impacts to our community and culture. Our municipal and city governments also had elections in which impacts each of our villages and Nuiqsut was just participating in whaling and other cultural events. Please respond to this request at your earliest convenience. I have also cc'd our Executive Director, Morrie Lemen, Jr., as well.
