As the three Neets'ąįį Gwich'in Tribal governments of Vashrąįį K'ǫǫ (Arctic Village) and Viįhtąįį (Venetie), we write in unified opposition to provisions in the budget reconciliation bill that would unnecessarily and irresponsibly pave the way for oil and gas development in the Arctic National Wildlife Refuge.

Our people have lived in deep spiritual and cultural connection with the Porcupine Caribou Herd for countless generations. Every season, the herd provides our people with sustenance both practically and spiritually. However, our way of life depends on a healthy Porcupine Caribou herd—one of the last remaining large caribou herds in the country—being able to traverse the land of the Arctic Refuge as they have for millennia.

The provisions outlined in the budget reconciliation bill targeting the Arctic Refuge seek to reinstate flawed leases, waive environmental and subsistence reviews, and block judicial oversight. These provisions represent an unprecedented attack on both our rights as Indigenous people and the irreplaceable landscapes that sustain our people. Drilling in the Arctic Refuge would cause irrevocable damage to the caribou's migratory path and, in turn, the Gwich'in cultural and spiritual connection to them.
