1	SECTION 1. SHORT TITLE.
2	This Act may be cited as the "Northwest Straits Ma-
3	rine Conservation Initiative Reauthorization Act of 2025".
4	SEC. 2. REAUTHORIZATION OF NORTHWEST STRAITS MA-
5	RINE CONSERVATION INITIATIVE ACT.
6	The Northwest Straits Marine Conservation Initiative
7	Act (title IV of Public Law 105–384; 112 Stat. 3458) is
8	amended—
9	(1) in section 402, by striking "Commission (in
10	this title referred to as the 'Commission')." and in-
11	serting "Commission."; and
12	(2) by striking sections 403, 404, and 405 and
13	inserting the following:
14	"SEC. 403. DEFINITIONS.
15	"In this title:
16	"(1) Commission.—The term 'Commission'
17	means the Northwest Straits Advisory Commission
18	established by section 402.

1	"(2) Marine resources committee.—The
2	term 'marine resources committee' means a county
3	government committee that assists in assessing ma-
4	rine resource and conservation needs.
5	"(3) Northwest straits region.—The term
6	'Northwest Straits region' means the marine waters
7	of the Strait of Juan de Fuca and of Puget Sound
8	from the Canadian border to the south end of Sno-
9	homish County.
10	"(4) Tribal Government.—The term 'Tribal
11	government' means the recognized governing body of
12	any Indian or Alaska Native tribe, band, nation,
13	pueblo, village, community, component band, or com-
14	ponent reservation individually identified (including
15	parenthetically) in the list published most recently as
16	of the date of enactment of the Northwest Straits
17	Marine Conservation Initiative Reauthorization Act
18	of 2025 pursuant to section 104 of the Federally
19	Recognized Indian Tribe List Act of 1994 (25
20	U.S.C. 5131).
21	"(5) Under Secretary.—The term 'Under
22	Secretary' means the Under Secretary of Commerce
23	for Oceans and Atmosphere.
24	"SEC. 404. MEMBERSHIP OF THE COMMISSION.
25	"(a) Composition.—

1	"(1) In general.—The Commission shall be
2	composed of 14 members, except as provided in
3	paragraph (2), who shall be appointed as follows:
4	"(A) One member appointed by a con-
5	sensus of the members of a marine resources
6	committee for San Juan County, Washington.
7	"(B) One member appointed by a con-
8	sensus of the members of a marine resources
9	committee for Island County, Washington.
10	"(C) One member appointed by a con-
11	sensus of the members of a marine resources
12	committee for Skagit County, Washington.
13	"(D) One member appointed by a con-
14	sensus of the members of a marine resources
15	committee for Whatcom County, Washington.
16	"(E) One member appointed by a con-
17	sensus of the members of a marine resources
18	committee for Snohomish County, Washington.
19	"(F) One member appointed by a con-
20	sensus of the members of a marine resources
21	committee for Clallam County, Washington.
22	"(G) One member appointed by a con-
23	sensus of the members of a marine resources
24	committee for Jefferson County, Washington.

1	"(H) Two members appointed by the Sec-
2	retary of the Interior, in coordination with the
3	Northwest Indian Fisheries Commission and in
4	consultation with the Tribal governments af-
5	fected by this title, to represent the interests of
6	such Tribal governments.
7	"(I) One member appointed by the Gov-
8	ernor of the State of Washington to represent
9	the interests of the Puget Sound Partnership.
10	"(J) Four members appointed by the Gov-
11	ernor of the State of Washington who—
12	"(i) are residents of the State of
13	Washington; and
14	"(ii) are not employed by a Federal,
15	State, or local government, excluding an
16	institution of higher education.
17	"(2) Additional members.—The Commission
18	may, as determined necessary to improve the ability
19	of the Commission to perform the duties of the
20	Commission under section 406(b), appoint members
21	in addition to those appointed under paragraph (1).
22	Any such additional member shall be appointed by
23	a consensus of the members of a marine resources
24	committee that is not described in such paragraph.

1	"(b) Vacancies.—A vacancy in the Commission
2	shall be filled in the manner in which the original appoint-
3	ment was made.
4	"(c) Chairperson.—The Commission shall select a
5	Chairperson from among its members.
6	"(d) Meeting.—The Commission shall meet at the
7	call of the Chairperson, but not less frequently than quar-
8	terly.
9	"(e) Liaison.—
10	"(1) IN GENERAL.—The Under Secretary, in
11	consultation with the Commission, shall appoint an
12	employee of the National Oceanic and Atmospheric
13	Administration—
14	"(A) to serve as a liaison between the
15	Commission and the Department of Commerce;
16	"(B) to coordinate programs of the Na-
17	tional Oceanic and Atmospheric Administration
18	with activities related to the goal of the Com-
19	mission described in section 406(a); and
20	"(C) to perform additional liaison func-
21	tions benefitting the Commission and the Na-
22	tional Oceanic and Atmospheric Administration,
23	which may include, as agreed to by the Com-
24	mission and the National Oceanic and Atmos-
25	pheric Administration, attending meetings and

1	other events of the Commission as a nonvoting
2	participant.
3	"(2) Limitation.—Service as a member of the
4	Commission by the employee appointed under para-
5	graph (1)—
6	"(A) is limited to the employee's service as
7	a liaison; and
8	"(B) does not obligate the employee to per-
9	form any duty of the Commission under section
10	406(b).
11	"(f) Administration.—The Commission may enter
12	into cooperative agreements with the State of Washington
13	for staffing and administrative services for the purposes
14	of supporting the duties of the Commission under section
15	406(b).
16	"SEC. 405. GOAL AND DUTIES OF THE COMMISSION.
17	"(a) Goal.—The goal of the Commission is to pro-
18	tect and restore the marine waters, habitats, and species
19	of the Northwest Straits region to achieve ecosystem
20	health and sustainable resource use by—
21	"(1) designing and recommending projects that
22	are driven by the best available science, local prior-
23	ities, community-based decisions, and the ability to
24	measure results;

1	"(2) building awareness and stewardship and
2	making recommendations to improve the health of
3	the marine resources of the Northwest Straits re-
4	gion;
5	"(3) maintaining and expanding diverse mem-
6	bership and collaboration with partner organizations,
7	such as the Puget Sound Partnership;
8	"(4) expanding partnerships with Tribal gov-
9	ernments and continuing to support Tribal treaties,
10	cultures, and subsistence and Tribal treaty rights;
11	and
12	"(5) recognizing the importance of economic
13	and social benefits that are dependent on marine en-
14	vironments and sustainable marine resources.
15	"(b) Duties.—The duties of the Commission are the
16	following:
17	"(1) To provide resources and technical support
18	for marine resources committees.
19	"(2) To work with such marine resources com-
20	mittees and appropriate entities of Federal, State,
21	and local governments and Tribal governments to
22	provide advice in developing regional programs to
23	monitor the overall health of the marine ecosystem
24	of the Northwest Straits region.

1	"(3) To collect marine resources data and iden-
2	tify factors adversely affecting or preventing the res-
3	toration of the health of the marine ecosystem and
4	coastal economies of the Northwest Straits region to
5	inform decisionmakers.
6	"(4) To develop scientifically sound restoration
7	and protection recommendations, informed by local
8	priorities, that address such factors.
9	"(5) To serve as a public forum for the infor-
10	mal discussion of policies and actions, with respect
11	to the marine ecosystem of the Northwest Straits re-
12	gion, of Federal, State, or local governments, Tribal
13	governments, or the Government of Canada.
14	"(6) To inform appropriate authorities and
15	local communities about the marine ecosystem of the
16	Northwest Straits region and about issues relating
17	to the marine ecosystem of the Northwest Straits re-
18	gion.
19	"(7) To consult with all affected Tribal govern-
20	ments in the Northwest Straits region to ensure that
21	the work of the Commission does not violate Tribal
22	treaty rights.
23	"(c) COORDINATION AND COLLABORATION.—The
24	Commission—

1	"(1) shall carry out the duties described in sub-
2	section (b) in coordination and collaboration, as ap-
3	propriate, with Federal, State, and local govern-
4	ments and Tribal governments, including by—
5	"(A) providing technical support and as-
6	sistance to any Tribal government seeking rep-
7	resentation and participation on the Commis-
8	sion; and
9	"(B) supporting the work and duties of the
10	liaison to the Commission under section 405(e);
11	and
12	"(2) may enter into cooperative agreements
13	with nonprofit entities, such as the Northwest
14	Straits Foundation, to provide assistance, including
15	financial assistance, in carrying out the duties de-
16	scribed in subsection (b).
17	"(d) Limitations.—Nothing in this title provides
18	the Commission with authority to issue regulations or im-
19	plement any Federal law or regulation.
20	"(e) Acceptance of Donations.—For purposes of
21	carrying out this section, the Commission may solicit, ac-
22	cept, receive, hold, administer, and use gifts, devises, and
23	bequests without any further approval or administrative
24	action.
25	"(f) Annual Report.—

1	"(1) In General.—Each year, the Commission
2	shall prepare, submit to the Committee on Com-
3	merce, Science, and Transportation and the Com-
4	mittee on Appropriations of the Senate, the Com-
5	mittee on Natural Resources and the Committee on
6	Appropriations of the House of Representatives, and
7	the Under Secretary, and make available to the pub-
8	lic a report describing—
9	"(A) the activities carried out by the Com-
10	mission during the preceding year; and
11	"(B) the progress in achieving the bench-
12	marks described in paragraph (2).
13	"(2) BENCHMARKS.—The benchmarks de-
14	scribed in this paragraph are the following:
15	"(A) Protection and restoration of marine,
16	coastal, and nearshore habitats within the
17	Northwest Straits region.
18	"(B) Protection and restoration of marine
19	resources populations to healthy, sustainable
20	levels.
21	"(C) Improvement of the water quality of
22	the Northwest Straits region.
23	"(D) Collection of high-quality data and
24	promotion of the use and dissemination of such
25	data for the purposes of ecosystem monitoring.

1	"(E) Promotion of stewardship and under-
2	standing of marine resources of the Northwest
3	Straits region through education and outreach,
4	including by targeted outreach to
5	underresourced communities.
6	"SEC. 406. SUNSET.
7	"The authority to carry out this title shall terminate
8	on the date that is 7 years after the date of the enactment
9	of the Northwest Straits Marine Conservation Initiative
10	Reauthorization Act of 2025.".
