NGSA and Center for LNG Welcome Permitting Reform Efforts, SPEED Act

(Washington, D.C.) – The Natural Gas Supply Association (NGSA) and the Center for LNG (CLNG) released the following joint statement in support of the *Standardizing Permitting and Expediting Economic Development* (SPEED) Act introduced by House Committee on Natural Resources Chairman Bruce Westerman and Ranking Member Jared Golden.

Dena Wiggins, President and CEO of the Natural Gas Supply Association, said:

“The Natural Gas Supply Association welcomes the long-term regulatory certainty outlined in the SPEED Act –certainty that is needed for natural gas infrastructure investment.

The U.S. Supreme Court’s recent decision in *Seven County Infrastructure Coalition vs. Eagle County*, has helped to streamline the scope of NEPA reviews but the SPEED Act takes this a step further by codifying the Court’s core holdings in statute for consistency across agencies.

NGSA applauds Chairman Westerman and Ranking Member Golden for their efforts.”

“The Center for LNG (CLNG) welcomes the bipartisan SPEED Act and its efforts to provide a more predictable permitting process. More certainty in the permitting process for LNG exports and energy infrastructure will further unlock the many benefits of U.S. LNG.
