Mr. MOOLENAAR (for himself, Mr. CONNOLLY, Mr. MCCORMICK, Mr. GRIFFITH, Mr. LYNCH, and Mr. MOULTON) introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To reauthorize the Adams Memorial Commission, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “The Adams Memorial-
5 Great American Heroes Act”.

6 **SEC. 2. EXTENSION OF AUTHORITY; LOCATION OF MEMO-**
7 **RIAL.**

8 (a) ADAMS MEMORIAL COMMISSION.—Section 2406
9 of the John D. Dingell, Jr. Conservation, Management,
10 and Recreation Act (Public Law 116–9) is amended—

1 (1) in subsection (l), by striking “2025” and in-
2 serting “2032”; and

3 (2) by adding at the end the following:

4 “(n) AUTHORIZATION OF APPROPRIATIONS.—Not-
5 withstanding other provision of law, there are authorized
6 to be appropriated \$50,000,000 to carry out the purposes
7 of this section, subject to the following limitations:

8 “(1) NON-FEDERAL MATCH REQUIREMENT.—
9 Any Federal funds made available under this section
10 shall be matched on a 1-to-1 basis by non-Federal
11 contributions.

12 “(2) LIMITATION ON ADMINISTRATIVE COSTS.—
13 Not more than 4 percent of Federal funds made
14 available under this section may be used for admin-
15 istrative expenses.”.

16 (b) COMPLIANCE WITH STANDARDS FOR COMMEMO-
17 RATIVE WORKS.—Section 1(c) of Public Law 107–62 (115
18 Stat. 411; 124 Stat. 1192; 127 Stat. 3880; 133 Stat. 750)
19 is amended—

20 (1) by striking “The establishment” and insert-
21 ing “Notwithstanding section 8908(c) of title 40,
22 United States Code, the establishment”; and

23 (2) by striking “2025” and inserting “2032”.

24 (c) LOCATION OF COMMEMORATIVE WORK.—Section
25 2 of Public Law 107–315 (116 Stat. 2763) is amended—

1 (1) by striking “The commemorative” and in-
2 serting “(a) Except as provided in subsection (b),
3 the commemorative”; and

4 (2) by adding at the end the following:

5 “(b) The commemorative work may be located within
6 the area generally depicted as ‘Adams Memorial: Eligible
7 Additional Area’ on the map titled ‘Adams Memorial: Eli-
8 gible Additional Area’ prepared by the Adams Memorial
9 Commission and dated February 25, 2025.”.
