- **H.R. 1366 (Rep. Amodei)**, “Mining Regulatory Clarity Act of 2025” (*Amendments to H.R. 1366 must be drafted to the amendment in the nature of a substitute, attached to this notice*)
- **H.R. 2306 (Rep. Moolenaar)**, “The Adams Memorial-Great American Heroes Act”
- **H.R. 2815 (Rep. Begich)**, “Cape Fox Land Entitlement Finalization Act of 2025”
