SOME REPORTED AND PUBLISHED CASES OF INTEREST

REPKO V. COUNTY OF GEORGETOWN

Repko among many others similarly situated and represented by Mr. Goldfinch, brought suit against Georgetown County. It was alleged that the County breached its own ordinance by reducing a Letter of Credit that was deposited with the County, on behalf of the Developer/Development where Repko and the others owned undeveloped property. The property was abandoned by the developer after the developer went bankrupt. It was later discovered that the County, contrary to its own ordinance, released the Letter of Credit to the Developer many times, and reduced the amount illegally, to less than the required amount.

Repko brought suit and tried the case to a jury in Georgetown County. Judge Culbertson granted a Directed Verdict based on 1. The County owed no duty to the Plaintiffs, 2. The Tort Claims Act Preempted any recovery, and 3. The County's own Sovereign Immunity Provision Preempted any recovery. Repko Appealed. The Court of Appeals reversed and remanded, agreeing with every point made by the Plaintiff, affirming three key elements of law: 1. That the county did owe a duty to the Plaintiffs because there was an affirmative undertaking, 2. That the Tort Claims Act provided for a gross negligence exception, because Defendants pled No. 12 of the Tort Claims Act as an affirmative Defense, and 3. Sovereign Immunity was abolished with the enactment of the Tort Claims Act.

MURRAY V. D.R. HORTON

Murray received third degrees burns on nearly a third of his body when he opened the oven to change a lightbulb. His wife was trying to prepare the thanksgiving turkey when the lightbulb burned out. The oven tipped over because the subcontractor for D.R. Horton neglected to install the required anti-tip bracket, which mounts the oven to the floor or the wall. The oven's manufacturer and installation manual clearly indicated that the oven must not be used without the anti-tip bracket and that severe injury or death could occur without its use.

D.R. Horton removed the case to federal court and filed a Motion for Summary Judgement based on The Statute of Repose. The lawsuit had been filed less than a week after D.R. Horton claimed the 8 years had run. Murray asserted that the Statute of Repose was inapplicable because the oven was not a fixture. The Statute of Repose only applies to fixtures, and Murray claimed that, because the oven was not mounted with the anti-tip bracket, that it should not be considered a fixture. Judge Harwell issued an order agreeing with the Plaintiffs and giving the first real guidance on fixtures in South Carolina in nearly a century. The case was soon thereafter settled for a confidential amount.
