### John James Tintera P.G. 325 - Professional Resume 2019

<u>Summary:</u> John Tintera is a petroleum and environmental geologist as well as a regulatory expert in virtually all facets of oil and gas exploration, production, transportation, and environmental programs, including conventional and unconventional reservoirs. As the former *Executive Director* and 22 year veteran of the premier state oilfield regulator in the nation (*the Railroad Commission of Texas*) he has overseen the entire regulatory process, from drilling permits to compliance inspections, including oil spill response, detailed and high profile enforcement cases, pollution remediation, and pipeline transportation. His responsibilities as Executive Director have included complete and overall budget, personnel, policy implementation, and management of senior division heads of the 700 person State Agency, including Underground Injection Control, Pipelines Safety, and other delegated federal programs and grants.

Mr. Tintera has both B.S. and M.S. degrees in Geology with over 35 years of combined technical and managerial experience, 11 years as an industry petroleum geologist, 22 years with the state regulator, and multiple years in oil and gas policy analysis and implementation. He has an in- depth hands-on knowledge of the E&P industry and the state and federal regulatory framework that oversees it, including all applicable Railroad Commission of Texas and Texas Commission of Environmental Quality regulations. His knowledge of federal statutes including RCRA, CERCLA, SDWA, CWA, and OPA is thorough. In addition, he has a comprehensive knowledge of environmental assessment, remediation and emergency response.

A petroleum geologist, John has mapped and drilled dozens of prospects in his early career with large multinational oil companies and small independents. As an environmental geologist, he founded and ran the pollution cleanup section at the regulatory agency, bringing toxicologists, hydrologist and engineers into the agency for the first time to focus solely on complex environmental issues. In addition, he has been directly responsible for the state funded assessment and cleanup of over 3000 oil field pollution sites of virtually every type of contaminant possible in the oil field. He is also a hands on expert for emergency response, and has personally responded to and overseen dozens of major oil spills in a variety of environmental settings.

His service at the Railroad Commission culminated in serving as Executive Director of the agency from 2009 to 2012, when he retired from State service to go into the private sector.
