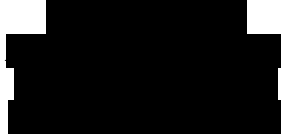

- Managed a small team of policy experts and outside lobbyists to establish close liaison with federal, state, local and tribal governments to effectively further the goals of the Consortium and Alaska Native health care
- Served as a member of the Consortium Executive Team responsible for guiding the direction of the Consortium and managing its operations
- Closely worked with congressional delegation to ensure that full funding for sanitation infrastructure for rural Alaska Native communities was included in the Infrastructure Investment and Jobs Act
- Worked with Congress and EPA in getting legislation enacted that created the USDA Small and Disadvantaged Communities program and ensuring that it was beneficial for Alaska
- Coordinated with congressional delegation and Indian Health Service to reverse the agency's decision that would have adversely impacted sanitation funding for Alaska tribes
- Advocated with the USDA and congressional committees to have the USDA Rural Alaska Villages Grant program reauthorized in the Farm Bill
- Drafted numerous oral and written testimony for the Consortium for legislative hearings at the state and federal level
- Drafted official comments for the Consortium on scores of federal and state agency requests for Notices of Proposed Rulemaking and requests for comment on policy decisions
- Negotiated and drafted several provisions that advanced the interest of Alaska tribes in the reauthorized Indian Health Care Improvement Act
- Served as the Alaska Area representative to the national Centers for Medicaid and Medicare Services Tribal Technical Advisory Group

- Met with numerous tribal leaders throughout Alaska and the United States discussing issues of concern in their communities and possible legislative solutions to those issues
