The case concerns Plaintiff Alaska Industrial Development & Export Authority's challenge to the Biden Administration's suspension of its subsequently cancelled oil and gas leases, and related actions.

Sovereign Inupiat for a Living Arctic Landscape v. BLM, No. 3:23-cv-00058-SLG (D. Alaska); No. 23-3627 (9th Cir.) – The Wilderness Society is a Plaintiff in this challenge to the BLM's approval of the Willow Master Development Plan.

Gwich'in Steering Committee v. Haaland, 3:20-cv-00204-SLG (D. Alaska) – The Wilderness Society is a Plaintiff in this currently stayed challenge to the Interior Department's 2020 Record of Decision for an Oil and Gas Leasing Program for the Coastal Plain of the Arctic National Wildlife Refuge and associated lease sale.
