Knowledge, Skills, and Abilities

Organization Builder. As Executive Director, I built up Biodiversity Conservation Alliance, originally a small, underfunded local conservation group with three staff, into a polished and professional conservation organization of statewide and regional scope, influence, and recognition.

- Created, developed, and managed annual BCA budget, which grew from \$125,000 to \$300,000, while raising salaries and instituting benefits including health insurance and retirement.
- Supervised a staff of four to six, including several employees who worked remotely from out-of-state offices.
- Served as editor in chief of quarterly BCA newsletter and builder of strong web presence
- Supervised (and for 3 years, personally managed) major donor development, grantwriting and reporting, fundraising letters, and fundraising events planning and execution.

Legal Watchdog. I have served as the organizational lead for setting up and managing a large number of administrative appeals and federal court cases.

- Led numerous litigation efforts challenging violations of NEPA, FLPMA, NFMA, and ESA in the context of oil and gas development, bighorn/domestic sheep conflicts, forest management, and rare species conservation.
- Prepared briefs for Interior Board of Land Appeals cases and Forest Service appeals and objections, killing outright one coalbed methane project in the Thunder Basin and brokering a settlement for another with the strongest wildlife protections to date.

- Used Clean Water Act non-degradation standards to force abandonment of the 1,240-well Seminoe Road coalbed methane project, the largest oil and gas project to be killed during the Bush administration.
- Served as Wyoming representative in Oil Shale/Tar Sands litigation, generating a settlement that reduced the federal land available for leasing by about three-fourths.
- Successfully negotiated two-thirds of conservationists' priorities into the BiState sage grouse plan amendment on the Humboldt-Toiyabe N.F., resulting in the strongest sage grouse protections to date.

Opinion Leader. I am a prolific and hard-hitting media presence, and have appeared as a spokesperson in countless newspaper, radio, and television news stories and venues across the nation, including NPR, New York Times, the Washington Post, and many others. In this role, I have served as:

- A regular Contributing Writer to The Hill, which gives me a DC-based platform for policy-related opinion pieces.
- Regional Media Coordinator under the Rocky Mountain Energy Campaign from 2005 to 2010, generating hundreds of individual news stories, op-eds (written by myself and recruited from among diverse spokespersons), editorials, and letters to the editor.
- Developer of advanced media strategies.
- Manager of social media platforms such as 'Absolutely No CRED' and 'Save the Greater Sage-grouse' Facebook pages in addition to organizational pages
- Wyoming Humanities Council speakers' bureau traveling lecturer, in 2006, 2007, 2008, 2010, 2011, 2014, and 2016.
- Public Interest Environmental Law Conference panelist and panel organizer on topics including oil and gas development, grasslands conservation, wind power, sage grouse, livestock grazing, and the right-wing public lands takeover movement.

Policy Mover and Shaker. I have worked longitudinally for conservation advocacy, in consortium with Congress and with a wide spectrum of administration policymakers including Interior, Energy, Agriculture, Office of Management and Budget, and Council on Environmental Quality. A few examples include:

- In 2009, I proposed programmatic plan amendments to increase sage grouse conservation which were adopted in a limited fashion
- I served to advance pro-active legislation such as America's Wildlife Heritage Act (codifying species viability requirements for BLM and the Forest Service) and the soon-to-be-introduced Wildlife Corridors Conservation Act.
- I petitioned for and secured 'Very Rare or Uncommon' designation for the Adobe Town proposed wilderness under Wyoming state law.
- I continue to cultivate champions and to lobby against harmful right-wing riders designed to undermine the Endangered Species Act, sage grouse protections, and public ownership of public lands.
- Recently, I negotiated IM 2014-100 (with fossil fuel leasing moratoriums, 4-mile lek buffers in interim projects, and a rangewide plan amendment for Gunnison sage grouse protection) in exhchange for a six-month delay in Gunnison sage grouse listing. As a

result, this bird was listed as a 'threatened species' without a 4(d) Rule that weakens legal protections.

Science Conduit. As a published scientist, I have the necessary ability to bridge the communication gap between the ivory tower of academia and the world of policy and bureaucrats. In this role, I have:

- Recruited allies from within often-hostile institutions willing to provide tips or key information.
- Canvassed available scientific studies to compile them into strong cases for conservation in the form of citizens' alternatives for land-use plans, Endangered Species Act petitions, or NEPA comments.
- Ghost-written scientist sign-on letters to support conservation initiatives.

Campaign Strategist. I have been a central strategist and on-the-ground organizer for a number of long-term conservation campaigns. With this comes positionality and access to promote:

- Grassroots advocacy at public events, organizing public outings and media tours to threatened landscapes
- Recruiting diverse allies and building coalitions.
- Planning and executing camopaign events.
- Developing strategic plans and campaign plans that map out the pathway to success, creating synergies between legal, media, organizing, and political aspects of the campaign.
