On **Thursday, June 18, 2020 at 3:30 p.m. EDT, via Cisco WebEx**, the Subcommittee on National Parks, Forests, and Public Lands will hold a legislative hearing on the following bills:

- [\*\*H.R. 244\*\*](#) (**Rep. Chris Stewart**), To maximize land management efficiencies, promote land conservation, generate education funding, and for other purposes. *“Advancing Conservation and Education Act.”*
- [\*\*H.R. 1267\*\*](#) (**Rep. Greg Gianforte**), To designate a mountain ridge in the State of Montana as “B-47 Ridge”. *“B-47 Ridge Designation Act.”*
- [\*\*H.R. 2611\*\*](#) (**Rep. Jared Huffman**), To support the establishment and improvement of communications sites on or adjacent to Federal lands under the jurisdiction of the Secretary of the Interior or the Secretary of Agriculture through the retention and use of rental fees associated with such sites, and for other purposes. *“Public Lands Telecommunications Act.”*
- [\*\*H.R. 3682\*\*](#) (**Rep. Ben Ray Luján**), To provide for greater consultation between the Federal Government and the governing bodies of land grant-mercedes and acequias in New Mexico and to provide for a process for recognition of the historic-traditional boundaries of land grant-mercedes, and for other purposes. *“Land Grant and Acequia Traditional Use Recognition and Consultation Act.”*
- [\*\*H.R. 5040\*\*](#) (**Rep. John Curtis**), To direct the Director of the Bureau of Land Management to study the effects of drone incursions on wildfire suppression, and for other purposes. *“Aerial Incursion Repercussion (AIR) Safety Act of 2019.”*
- [\*\*H.R. 7045\*\*](#) (**Rep. Ed Case**), To require the Secretary of Agriculture to conduct a study on lands that could be included in a National Forest in Hawai’i, and for other purposes.
- [\*\*H.R. 7099\*\*](#) (**Rep. Raúl Grijalva**), To provide for the conveyance of a small parcel of Coconino National Forest Land in the State of Arizona.

**The hearing will take place via Cisco WebEx online video conference platform and will be livestreamed on Facebook live and YouTube. Witnesses will testify by invitation only.**
