The Corps Network has a national cooperative agreement with the National Park Service. Through this agreement, over the past 36 months, TCN has received \$751,233 which we sub-granted to Corps (AMC, LCCC, MHYC, and RMYC) for trail projects.

The Corps Network has a national cooperative agreement with the Fish and Wildlife Service through which we received \$572,967 in FY20 and then sub-granted to three Corps (CTW, GYF, and IIC) for education, research, and trail projects.

TCN has a national cooperative agreement with the US Forest service. Over the last three years, we have received 976,085 from USFS which we have sub-granted to nine Corps (ACE, AYW, CCWV, Civic Works, Climb CKC, EFA, GBI, Kupu, and UTCC.to support individual placements/interns. TCN retained \$91,752 to support three interns at TCN.
