As President and CEO of the National Park Foundation, I serve as the a fiduciary of the organization. The National Park Foundation is the official nonprofit charitable partner of the National Park Service. Although the Foundation does not have a financial interest in any of the bills being reviewed at the hearing, our mission is to generate private support and build strategic partnerships to protect and enhance America's national parks for present and future generations. Because there are over 450 park partners, it is possible that the Foundation may have granted funds to one of those partners over the last 36 months, and a partner (or donor to the Foundation) could be working with a group or individual supporting one of these bills. To the best of my knowledge, the Foundation has not supported specific funds that would directly aid any of these legislative items.
